Entries

Eligibility: NCA Draft Tests are open to purebred Newfoundland dogs of either sex that are at least 18 months old on the date of the test. Other restrictions listed in the NCA Draft Test Regulations also apply. In accordance with NCA rules, other breeds may be eligible to enter provided the test is not full, other breeds are not judged until after all Newfoundland's have been judged, including bitches in season, and the Newfoundland test is considered finished.

General Information:

ENTRY FEES & LIMITS: The entry fee is \$45 for a single or team entry per day. Entries are limited to 5 Single or Team entries in DDX/TDDX and 15 BDD, DD/TDD each day for a total of 15 entries throughout divisions. An alternate list will be kept. The minimum is 5 entries each day to hold tests. Post Entries will not be allowed for this test.

NCA Member Entries must be postmarked March 3, 2023 or later. Entries received without a CHECK MARK in the box indicating that the owner/co-owner is an NCA member will be assumed to come from a non-NCA member. Entries received with postmarks earlier than the stated date will be returned. To take advantage of the early entry rule, if the dog is co-owned, either all co-owners of the dog must be NCA members or the handler must be an NCA member.

NON NCA Member Entries must be postmarked March 13, 2023 or later. Entries received with postmarks earlier than the stated date will be returned. After this date, all injuries will be treated equally, whether the owner is an NCA member or not.

ENTRY CLOSING. Entries close at 5:00 p.m. CDT April 3, 2023. Every effort will be made to notify each handler at least 10 days before the test. If entries exceed the published entry limit, the draft test secretary will notify alternates of the position on the alternate list as per regulations.

Acceptance of Entries. Entries will be accepted by mail. The slots available will be filled in the following manner:

- 1) If the number of entries with the same date exceeds the number of available slots, a drawing will take place to fill the vacancies and determine the alternates for each test.
- 2) All entries received after the entry limit is filled will be placed on an alternate list by order of those without titles in order of postmark, followed by requalifiers in order of postmark.
- 3) If absentees or withdrawals occur prior to the start of the test, the test secretary will substitute entries from the alternate list.

WITHDRAWING ENTRIES AND REFUNDS: To withdraw an entry, the entrant must notify the test secretary by telephone, email or U.S mail. The secretary must confirm receipt of such notifications. The entrant will receive a full refund of the entry fee if the notification is received prior to the closing date for entries. After the closing date has passed, no refunds will be given, with the exception of alternates that did not get into the test. In addition, an entrant with one dog in the test and another on the alternate list may not substitute one dog for the other. If the entrant must pull the entered dog, then the first dog on the alternate list will fill the opening. If the test does not meet the minimum entry requirements, refunds will be given.

CHANGING TO TEAM DIVISION: A change of entry from individual to team division must be submitted to the Test Secretary by 6:00 PM the night before the test in accordance with the NCA Draft Test Regulations.

SPECTATORS AND UNENTERED DOGS: Spectators are welcome at the Draft Test as long as the following test and COVID 19 rules are followed. Unentered dogs, and those that are not being tested at the time are not permitted in the official Draft Test areas. As a courtesy to our exhibitors, we ask that all dogs be kept quiet and leashed or crated. As Specified in the Draft Test Regulations, handlers and dogs (except bitches in season) are allowed a 30 minute period to familiarize themselves with the test areas. They may not walk the Maneuvering or Distance Freight Haul courses after this period.

Bitches in Season. Bitches in season or with ovarian sparing spay will be allowed to compete after all other entries. They must be crated away from the other entries in an area designated by the test committee. Their handlers should notify a member of the test committee upon their arrival, or earlier, if possible.

OBTAINING REGULATIONS: This test will be judged under the rules of NCA Draft Test Regulations, copyrighted 2022. It is the responsibility of the handler to obtain and know these rules. Copies of these regulations may be obtained at www.ncanewfs.org

EQUIPMENT: Each exhibitor is responsible for his or her own draft equipment and freight haul load.

DDX WEIGHT EXCHANGE: They DDX freight exchange will be 40-45 # dry dog food.



TROPHIES: Each qualifier will receive a trophy to commemorate their new title.

WAIVER OF RIGHTS – Animals in Distress: The Newfoundland Club of America, Inc, and the regional club hosting this event reserve the right to remove any animal in distress from a parked vehicle or crate, and all persons attending this dog event hereby waives any claim for damages against the Club for such removal. The NCA regards the health, safety and life of any dog on the event grounds to be paramount to other property or privacy rights. If the owner cannot be found in a timely manner, we will take whatever action is necessary for the safety of the dog, which may include breaking windows to enter a vehicle. Dogs found in an unsafe environment, distress, or in harm's way (for example, left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment and subject to appropriate discipline.

NCA AGGRESSION POLICY The WDC and the NCA have adopted the AKC official policy concerning dog attacks that lead to an injury, either to a person or to another dog. Also, Advanced Draft Test judges may excuse, and even ask to have removed from a test site, if necessary, any dog that appears dangerous to other dogs or persons

AKC Rules Applying to Dog Shows: Chapter 11, Section 15- Any dog, that in the opinion of the Event Committee, attacks a person or dog at an AKC event, resulting in an injury, and is believed by that Event Committee to present a hazard to persons or other dogs, shall be disqualified by the Event Committee pursuant to this section, a report shall be filed with the Executive Secretary of The American Kennel Club. The disqualified dog may not again compete at any AKC event nor be on the grounds of an AKC event unless and until, following application for reinstatement by the owner to the 11 American Kennel Club, the owner receives official notification in writing from the AKC that the dog's eligibility has been reinstated.

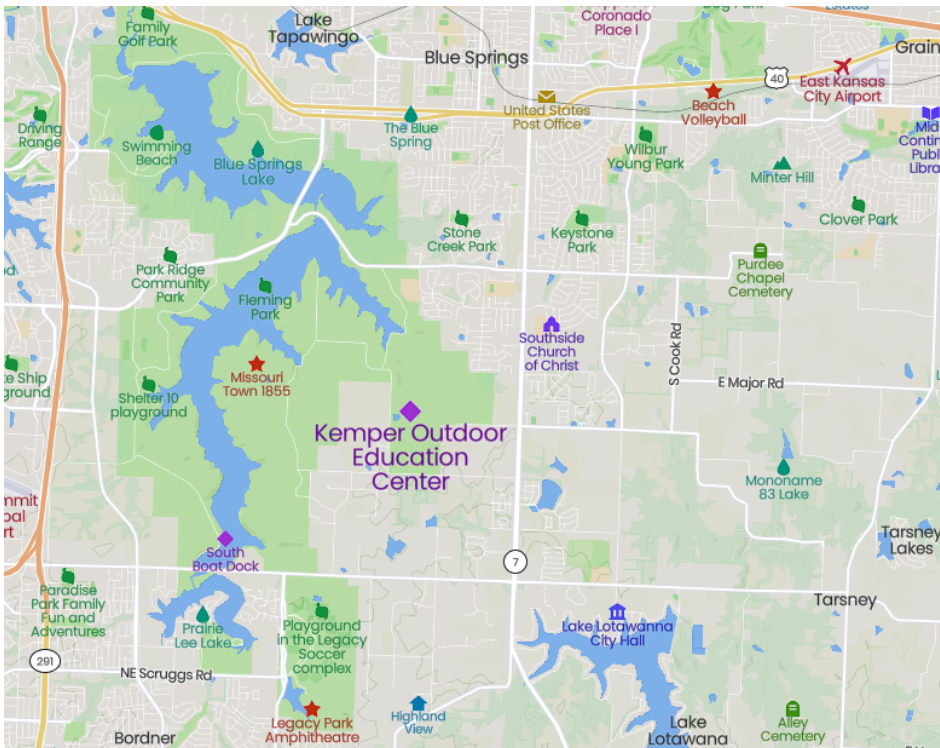

1. Go south 5 miles on 7 Highway
2. Turn right on Cowherd Road (by Doug's Outdoor Power and Cell Phone Tower)
3. Turn right on Jasper Bell Road (first right)
4. Go a half-mile to Kemper Outdoor Education Center
5. Entrance on right (stone wall and iron gates at entrance)

From 291 Highway & Colbern Road in Lee's Summit

1. Go east 3 miles on Colbern Road
2. Turn left (north) on Cyclone School Road
3. Turn right on Lochkirk
4. There's a jog in Lochkirk- go right at stop sign, then left
5. Right on Cowherd (T -intersection)
6. Take first left turn (Jasper Bell Road)
7. Go 0.5 miles to Kemper Outdoor Education Center
8. Entrance on right (stone wall and iron gates at entrance)

From Johnson County, Kansas

1. Go east on I-435 to I-470 East
2. Take the Colbern Road/Douglas Street exit (exit 9)
