**New Business:** Bob Kobzey

- **Preferred Lies** – definition requires clarification:
- For our purposes:
- If your ball is on the fairway and lies in a damaged area (divot, damaged area) you may mark it, lift, and replace the ball 6 inches from the marker, no nearer to the hole. If your ball lies on undamaged fairway you may not move it. This rule does not apply to balls that are in the rough, in a bunker, or in a hazard (staked) area. They must be played as is.
- Note: winter rules, when designated will apply to bunkers, where you may lift, rake the sand, and replace the ball. This does not apply to the preferred lies rule, and you must play bunker shots as they lie.
- The playing rules for the day will be communicated by the Club Captain before the round.
