

RELEASE OF LIABILTY WAIVER

1. The risk of injury from the activity and equipment involved in ATV activities is significant including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist. I knowingly and freely assume all such risks, both known and unknown even if arising from the negligence of those persons released from liability below, and assume all responsibility for my participation, I hereby assume all of the risks of participating in this event and certify that I am physically fit to do so, have sufficiently trained for participation in this event, and that I have not been advised otherwise by a qualified medical person; and, 2. I understand that the activities of motorized off road activities are physically and mentally intense. I understand the rules of play and will comply with all the rules and regulations. If I observe any unusual or unnecessary hazards during my participation, I will bring such to the attention of the nearest official as soon as practical and leave the area; 3. I, for myself and on the behalf of my heirs, assigns, personal representatives and next of kin, forever release and hold harmless The Tazewell County Fair Association, it's officers, directors, agents, Volunteers, and the sponsors. ("Releases") of the off road event, and the owners of the premises used to conduct the motorized off road activities, with respect to any and all injury, disability, death or loss of damages to person or property, whether caused by the negligence of the releases or otherwise. 4. I understand and agree that the release of liability agreement covers each and every motorized off road activity and /or event in which I participate or attend hereafter. 5. I understand that The Tazewell County Fair Association, it's officers, directors, agents, volunteers and sponsors do not provide health insurance. The undersigned further agrees to assume all responsibility for doctor, ambulance, hospital and medical expenses and any loss or injury to me and or personal property due to participation in any Tazewell County Fair Association Event.

Rules

ENTRIES:

You may enter as many machines in as many classes as you want (as time limits and total number of rider limits determined by the fair board allow). \$15.00 Entry Fee Applies to each Machine. Entry Fee Covers 1 Rider. Example: A Rider has 2 ATVs and wants to participate in 2 Classes on 2 different ATVs. That Rider would pay \$30.00. The Rider may participate in a larger Displacement Class on the same ATV as registered and pay only 1 Entry Fee.

RESTRICTIONS:

- 1. D.O.T. approved helmet and eye protection required.
- 2. Over the ankle leather boots, shirt (no tank tops), and full length pants are required.
- 3. Speed limit is 5 mph when not participating in an individual event.
- 4. No alcohol or drugs of any kind are allowed in the pit area.
- 5. Helmets must be worn at all times when riding ATV.
- 6. Due to Insurance Restrictions, no one under the age of 18 will be allowed to compete.
- 7. Any person who appears to be chemically or alcohol impaired will not be allowed to compete.
- 8. Non-conformance to the principles of this event will result in immediate disqualification; subsequent expulsion and all fees will be forfeited.
- 9. Riding is allowed ONLY between pits and event.

JUDGING:

A panel of judges will review all scenarios not covered by the listed rules; However, reserve the right to delete, add and amend.

All decisions made by the panel of judges are final.

RIDERS CONDUCT:

All riders shall conduct themselves in a respectful, sportsmanlike manner. Deliberate recklessness will be grounds for disqualification.

COURSE RULES:

- 1. We reserve the right to rework the course at any time during the event.
- 2.Stock and modified machines allowed. Any tire size will be allowed, chains or spikes will not.
- 3. Helmet & goggles must be strapped on before pulling up to the line.
- 4. Operator must stay on machine during the run, dismounting from the machine for more than 10 seconds terminates the run. Unless the

Rider is otherwise instructed to do so. Maintaining a safe competition is of paramount importance.

- 5. The Judges may ask the Rider to go to the start an begin the run again in cases where the course needs attention.
- 6. Any machine with a 2wd/4wd switch must stay in one position during the entire run.
- 7.Once forward progress stops, rider has 10 seconds to resume moving or run is over. After completing a race, riders will immediately head to the pit area. Reserve Seating for Riders is available beside the Announcer's Booth
- 8.All riders wishing to compete MUST attend the Rider's meeting before the races can begin.
- 9. Class jumping will be allowed as long as you are undersized for the class.
- 10.Starter controls the run. Rider's time will be recorded by a Time Keeper at the Finish Line. Timer starts when Flag drops.
- 11.In case of a breakdown, each rider is responsible for hooking the towrope to his/her own machine; any and all damages incurred when

being pulled are the solely responsibility of the rider.

- 12. Knocking over a barrel or cone, or any course infraction, will result in a 10 Second time penalty for each violation, as determined by the judges.
- 13. Exceeding the course limits, including the braking or stop line, will result in a 10 second penalty for each violation.
- 14. When registering for events, the individual must select their class The judges reserve the right and may place participants in a another class.
- 15. We reserve the right to combine competition classes, in the event of a lack of entries per class to keep winning fair. The number of participants in each class is at the discretion of the judges.
- 16. Unsportsmanlike conduct will not be tolerated. Any display of unacceptable behavior, decided by the judges, will result in disqualification. If the conduct continues, the participant or spectator may be escorted off the premises.
- 17. Participants and all ATV riders are required to wear a proper fitting, DOT certified helmet any time the ATV is in motion. Penalties will be enforced, and to be decided by the judges. Participants are required to wear eye protection.
- 18. The Judges and Officials reserve the right to inspect every ATV for proper safety equipment. Machines must have workable brakes and accelerator. Machines may be lightly modified, but must be safe to compete. Any modification that is deemed unsafe must be rectified before competition.

Photo/Audio/Video Release

As the participant, I understand that the participant may be photographed, audio and/or video recorded. I give consent to being photographed, audio and/or video recorded during their participation. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and/or assigns. This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. The undersigned has read and voluntarily signed the release and waiver of liability and indemnity agreement, and further agrees that no oral representations.
