

An ordinance appropriating certain money's.

Be it ordained by the mayor and Commissioners of the city of Garnett Kansas:

Section One :- that the sum of Three Hundred and Thirteen and 38/100 Dollars be and the same is hereby appropriated out of the General Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 5th day of February 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of Five Hundred and Fifty Nine and 45/100 Dollars be and the same is hereby appropriated out of the water works funds in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held the 5th day of February 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.

Section Three :- that the sum of Forty Four and 15/100 Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 5th day of February 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Four :- that the sum of Six Hundred and Eighty and 33/100 Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the City Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 5th day of February 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Five :- that the sum of Thirty Five and 50/100 Dollars be and the same is hereby appropriated out of the Cemetery Fund to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 5th day of February 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

~~Section Six :- that the sum of Dollars be and the same is hereby appropriated out of the Property Paving Tax Fund No in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.~~

~~Section Seven :- that the sum of Fifty Seven and 60/100 Dollars be and the same is hereby appropriated out of the Property Paving Tax Fund No 2 in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 5th day of February 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.~~

~~Section Eight :- that the sum of Dollars be and the same is hereby appropriated out of the Funds of Sewer District no in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.~~

~~Section Seven that the sum of Twenty Eight and no/100 Dollars be and the same is hereby appropriated out of the Fire Department Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at ~~XXXXXXX~~ regular meeting of said Board held on the 5th day of February 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.~~

Section Eight that the Mayor and city clerk be and are hereby authorized and instructed to draw warrants on the city Treasurer to pay to Bills allowed in the forgoing sections of this ordinance.

Section Nine that this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the Mayor.
