- Removal of Art: Friday, April 26 - 12-6 pm; Saturday April 27 – 12-3 pm**

ELIGIBILITY:

- This show is open to all students, grades 5-8 in Wayne County.

ENTRY FEES:

- The fee is \$50.00 per building. Payment due by February 15, 2019.
- Invoice is attached. Please take care of payment prior to delivery of art.
- Checks are to be payable to Wayne County Council for the Arts.
- All fees are non-refundable.

PRESENTATION SPECIFICATIONS:

- 8 ft x 8 ft space for hanging MATTED work
- Pedestals will be available for sculptural/3D work on a first-requested-first served basis.
- Limited space is available for 3D work and we recommend 2 pieces per student.
- Teachers must prepare a LABEL with student's name, grade and school
- Teachers must bring a SIGN with the Name of the School/District
- Matted work must be mounted with push pins or staples only. NO Velcro or Adhesives.
- Putty can be used on pedestals
- All work must remain in the gallery until the end of the show.

ADDITIONAL INFORMATION:

- Please provide a full list of students participating, including name, grade, school and teacher's name.
Email it by the same day as delivery of art to info@wayne-arts.com.
- Teachers please provide a snack for the reception. Beverages and paper goods will be provided.
