

**AN ORDINANCE OF THE VILLAGE OF INNSBROOK  
TO AMEND THE BUDGET FOR THE 2017-2018 FISCAL YEAR.**

**WHEREAS**, the Village of Innsbrook’s operating budget for fiscal year 2017-2018 was approved and adopted by the Board of Trustees pursuant to the statutes of the State of Missouri; and

**Section 1:** The 2017-2018 fiscal year budget of the Village of Innsbrook is hereby amended as follows:


