#### Letter from the President

#### Ms. Peggy Pennington



Welcome, GAMbit readers, to a new year, a new decade, and a renewed determination to support gifted students in the state of Missouri! The upcoming year is setting up to be an exciting one as The Gifted Association of Missouri has many events in the works for the upcoming year.

#### GAM Day at the Capitol - February 26, 2020

First up at the end of February is GAM Day at the Capitol. This special event is an opportunity to teach students about how to have a role in the legislative process. When I first started working with the Gifted Association of Missouri, I was nervous about contacting my legislator and being involved in the legislative process. I thought, "They don't want to hear from me. Will what I say even make a difference?" Yes. It does. What I share with my legislator does make a difference. I have the confidence that my legislator knows and understands my point of view. If you are bringing students to the day, take the time to contact your legislator in advance and set up an appointment to meet with him or her. We are also adding a registration form to our website for groups/schools that are attending so that we can recognize the schools that are attending.

#### Student Letter to a Legislator Contest

GAM will also have a student contest in conjunction with the day. Last year's Letter to a Legislator Contest was so successful that we are doing it again.

Winners will be recognized during the GAM Day at the Capitol event. Check out the GAM website to find more details. The deadline to enter student letters is February 15. We hope to see an inbox full of letters!

#### **Legislative Updates**

GAM also has legislative issues that are on our priority list. The first is House bill 1317 sponsored by Representative Chrissy Sommer (R-St. Charles) and Senate Bill 645 sponsored by Senator Denny Hoskins (R-Warrensburg) which have been filed. This legislation would require that every school in Missouri provide state approved gifted education programs for students identified as "gifted" under section 162.675 and that all program services are provided by teachers with a valid certification in gifted education.

A second important legislative issue is to support funding for the Missouri Scholars Academy and the Missouri Fine Arts Academy for the fiscal year 2021. The Scholars Academy is a three-week residential program at MU for 330 high school juniors who are academically gifted and The Fine Arts Academy is a three-week residential program at MSU for 150 rising high school juniors and seniors who are gifted in the arts. Please use your voice to help us support both important causes.

#### **New Teacher Workshop**

Another important event that we have coming up in 2020 will be our New Teacher Workshop which will be held at the SAGE Northland Innovation Center in Gladstone which is part of the North Kansas City School district. It will be held on July 27-28. The workshop is intended for teachers in before or

after their first year of teaching gifted, but anyone is invited to register and attend. The workshop focuses on issues from identification to certification to curriculum. It is a great way for teachers that are new to gifted to start to build a network of resources. Registration will be available soon via our website.

#### Vicky Bennett Outstanding Student Award

Also don't forget that May 1st is the deadline for the Vicky Bennett Outstanding Student award. The award recognizes with a \$250 scholarship a gifted student in grades 3-8 who has distinguished himself/herself in academic study, leadership, and/or the field of art/performance. 

The Gifted Association of Missouri requests your advocacy on the following issues:

#### **FUNDING FOR GIFTED EDUCATION PROGRAMS**

Support legislation that requires every school in Missouri provide state approved gifted education programs for students identified as "gifted" under section 162.675 and that all program services are provided by teachers with a valid certification in gifted education.

#### MO SCHOLARS ACADEMY & MO FINE ARTS ACADEMY

Support state funding for the Missouri Scholars Academy and Missouri Fine Arts Academy for June, 2021. The Scholars Academy is a three-week residential program at MU for 330 high school juniors who are academically gifted; The Fine Arts Academy is a three-week residential program at MSU for 150 rising high school juniors and seniors who are gifted in the arts.

#### MISSOURI SCHOOL FOUNDATION FORMULA FUNDING

Support increased funding for the Missouri School Foundation Formula. Support \$3.9 billion appropriation in House Bill 2 for the Department of Elementary & Secondary Education.


#### **OTHER GIFTED FACTS & FIGURES**

\$24,870,104 was appropriated for gifted education in FY2006. There were 295 school districts with state approved gifted programs. In FY2007, this amount was rolled into the new foundation formula. Without this line item providing earmarked funding for state approved gifted programs, those funds can be spent on other programs, and there are now only 215 school districts offering state approved gifted programs.

#### GAM 2020 STUDENT CONTEST Legislative Letter Contest

<u>Contest Description:</u> The GAM 2020 Student Contest, Legislative Letter Contest, is a challenge to gifted students grades 3-8 in Missouri to write a letter of support for one of the GAM sponsored pieces of legislation in the 2020 session. These are:

House Bill 1317 and Senate Bill 645 -- PROVISIONS FOR GIFTED EDUCATION
Sponsored by Representative Chrissy Sommer and Senator Denny Hoskins
This bill requires school districts to establish a state-approved gifted program if 3% or more of the students are determined to be gifted. Districts with average daily attendance of 350 or more students are required to have a teacher certificated to teach gifted education. Any teacher providing gifted instruction without a gifted-teaching certificate must participate in six hours per year of professional development regarding gifted services.

<u>What to do:</u> The contest will officially be released on the GAM website, www.mogam.org on JANUARY 13, 2020. First, go to www.mogam.org and download this document, which includes the student release statement on page 2. Next, you will create an individual letter (no groups or teams). This letter should be in support of GAM legislation and follow the following criteria:

- 1. The letter is to be written to the student's legislator in the district in which they live.
- The letter should be informative and provide a good understanding of the bill the student is in support of, what the bill means, and what that bill will mean for gifted programs in the state of Missouri.
- 3. The letter should include how this bill will impact them and gifted students across the state of Missouri. The letter should be addressed to the student's legislator and will be printed and delivered to the legislator after the contest.

The student should use their name and grade, and is encouraged to provide their address on the letter because they might receive a letter back from their legislator, but this is not required for submission.

#### AN ACT

To repeal section 162.720, RSMo, and to enact in lieu thereof one new section relating to gifted children.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 162.720, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 162.720, to read as follows:

- 162.720. 1. [Where a sufficient number of children] If three percent or more of students enrolled in a school district are determined to be gifted and their development requires programs or services beyond the level of those ordinarily provided in regular public school programs, [districts may establish special programs for such gifted children] the district shall establish a state-approved gifted program for gifted children.
- 2. The teacher or teachers providing gifted services to students in districts with an average daily attendance of more than three hundred fifty students shall be certificated in gifted education. In districts with an average daily attendance of three hundred fifty students or less, the teacher or teachers providing gifted services shall not be required to be certificated to teach gifted education, however such teachers shall annually participate in at least six clock hours of professional development focused on gifted services.
- 3. The state board of education shall determine standards for such gifted programs and gifted services. Approval of [such] gifted programs shall be made by the state department of elementary and secondary education based upon project applications submitted [by July fifteenth of each year] at a time and in a form determined by the department of elementary and secondary education.

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

HB 1317 2

[3.] 4. No district shall make a determination as to whether a child is gifted based on the child's participation in an advanced placement course or international baccalaureate course. Districts shall determine a child is gifted only if the child meets the definition of gifted children as provided in section 162.675.

- [4.] 5. Any district with a gifted education program approved under subsection [2] 3 of this section shall have a policy, approved by the board of education of the district, that establishes a process that outlines the procedures and conditions under which parents or guardians may request a review of the decision that determined that their child did not qualify to receive services through the district's gifted education program.
- [5-] 6. School districts and school district employees shall be immune from liability for any and all acts or omissions relating to the decision that a child did not qualify to receive services through the district's gifted education program.
- 7. The department of elementary and secondary education may promulgate rules to implement the provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable, and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2020, shall be invalid and void.

#### AN ACT

To repeal section 162.720, RSMo, and to enact in lieu thereof one new section relating to gifted children.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 162.720, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 162.720, to read as follows:

- 162.720. 1. [Where a sufficient number of children] If three percent or more of students enrolled in a school district are determined to be gifted and their development requires programs or services beyond the level of those ordinarily provided in regular public school programs, [districts may establish special programs for such gifted children] the district shall establish a state-approved gifted program for gifted children.
- 7 2. The teacher or teachers providing gifted services to students 8 in districts with an average daily attendance of more than three hundred fifty students shall be certified by the department in gifted 9 10 education. In districts with an average daily attendance of three hundred fifty students or less, the teacher or teachers providing gifted 11 12 services shall not be required to be certificated to teach gifted 13 education, however such teachers shall annually participate in at least 14 six clock hours of professional development focused on gifted services.
- 3. The state board of education shall determine standards for such **gifted** programs and **gifted services**. Approval of [such] **gifted** programs shall be made by the state department of elementary and secondary education based upon project applications submitted [by July fifteenth of each year] at a time and in a form determined by the department of elementary and secondary

- [3.] 4. No district shall make a determination as to whether a child is gifted based on the child's participation in an advanced placement course or international baccalaureate course. Districts shall determine a child is gifted 24 only if the child meets the definition of gifted children as provided in section 162.675.
  - [4.] 5. Any district with a gifted education program approved under subsection [2] 3 of this section shall have a policy, approved by the board of education of the district, that establishes a process that outlines the procedures and conditions under which parents or guardians may request a review of the decision that determined that their child did not qualify to receive services through the district's gifted education program.
  - [5.] 6. School districts and school district employees shall be immune from liability for any and all acts or omissions relating to the decision that a child did not qualify to receive services through the district's gifted education program.
  - 7. The department of elementary and secondary education may promulgate rules to implement the provisions of this section and may develop a process to certify teachers in gifted education. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable, and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2020, shall be invalid and void.



#### A Most Welcome Change



I watched as the students thought out loud, buzzing with ideas, discussing possible solutions for building a ship with only the given materials. All my time teaching in Florida this is what I envisioned a gifted program should look like. During my teaching career in Florida I taught many different subjects and grade levels; for 10 years I was the gifted coordinator for the middle school where I taught. This was a frustrating position because teachers and administrators were uneducated about gifted students, and honestly, not really interested in learning how to best meet their needs. There were no true gifted programs; in fact it was more of a "keep us legal" mentality and the students were placed in classes based on their standardized test scores with no enrichment opportunities. As a result, many gifted students were misunderstood and teachers actually said to me, "Are you sure they are gifted? I see no signs they are smart". I provided research based data, articles on gifted education, and designed a gifted program, all of which fell on deaf ears.

When I was offered a job at Phelps Center for Gifted Education in Springfield Missouri, I didn't know what to expect. The difference between my Florida experience and my Missouri experience is astonishing, to be frank. Springfield Public School System offers a variety of programs throughout the district that are a benefit to gifted students. Phelps specifically offers gifted students everything we know they need to be successful. Affective education, thinking skills, and a choice of what they get to learn. The teachers are well-trained to support the needs of gifted students, not only academically, but emotionally as well. The teachers are passionate and work to understand the varying needs of

each student. One thing I have learned over the past twenty years is teacher passion makes all the difference. As an outsider observing the interactions between the teachers and students, the students excitement over using thinking skills to complete a building challenge, seeing the growth in their ability to work cooperatively and finding ways to manage their emotional needs, has renewed my faith that we can truly provide educational programs, within the public school system, that meet the needs of our gifted population. I applaud Springfield Schools, and the state of Missouri for striving to meet the needs of all students, and understanding the uniqueness of gifted education.
