8. Pro-rata Discussion

Dr. Birkenmaier presented the draft FY16 pro-rata bill calculation for the Trustee review. The Treasurer's Office is waiting for some District's Annual Financial Report (AFR) to complete the FY16 revenue column. The revenues are used for the pro-rata share calculation against which the costs of services are distributed. Three billing option charts were presented to the Trustees for review. Discussion was had on whether to include the #204 litigation costs in the FY16 pro-rata billing.

President Thiessen requested Attorney Witt to research the option of charging interest to the districts who have not paid their full pro-rata due to the Treasurer's Office, or the option of escrowing their interest income until the pro-rata amount due is paid in full. *No action was taken at this time.*

10. District Updates

School District Updates:

The Lyons Township Treasurer's Office visited and made formal presentations to School Districts 101, 102, 103, 104, 105, 106, 108, 109, 204 & 217 throughout the months of October, November and December in 2016. The presentations were tailored to each district and outlined the significant cost savings form the shared services model & vastly higher interest earning revenues from pooled funds investment. The district presentations demonstrated full alignment with the State of Illinois Task Force on Local Government Consolidation and Unfunded Mandates, which is seeking to streamline government services, reduce costs to taxpayers, and consolidate redundant administrative duties/activities.

The LTTO has returned \$ 9.25 million in investment income to member districts as compared to an estimated \$ 1.56 million if districts were to independently invest taxpayer dollars. The LTTO cumulative interest earnings are \$ 3.65 million higher than the office's expenses, resulting in a 65.07% return to its member districts.

• LaGrange Area Department of Special Education (LADSE)

On December 14, 2016, Rob Pritts, Ken Getty and Dr. Birkenmaier met with Sheri Wernsing and Brian Riegler, LADSE administrators as a follow up to their request/resolution to withdraw from the Lyons TTO. Originally LADSE proposed a withdrawal effective June 30, 2017. The plan LADSE laid out included TTO training of LADSE staff who would be taking over the current TTO responsibilities; possible continuation of software licensing through the TTO; and the turnover of funds to LADSE's control. Dr. Birkenmaier distributed attachments responding to LADSE's questions, Cost Savings, Cost Shifting, Driving Force Motivating Withdrawal and LADSE's Current Status. President Thiessen requested a letter be directed to LADSE accepting their request to withdraw from the TTO.

MINUTES OF THE CLOSED MEETING OF THE LYONS TOWNSHIP TRUSTEES OF SCHOOLS January 9, 2017

1. Call to Order.

The Closed Session of the Lyons Township Trustees of Schools was called to order by President Michael Thiessen at the Township School Treasurer's Office, 22 Calendar Court, LaGrange, Illinois at 8:00p.m.

2. Roll Call.

Taken by President Thiessen. Present were President Thiessen, Trustee Tobolski, Trustee Dickman, Treasurer Susan Birkenmaier, and attorney Emily Witt.

3. The Board discussed the status of the litigation with School District 204. Trustee Dickman provided an update regarding the recent depositions. President Thiessen discussed a potential settlement and reiterated that that the TTO is willing to discuss settlement with School District 204.

Treasurer Birkenmaier again discussed her succession plan, as her contract expires June 30, 2017. She provided the Board with a list of potential options regarding her future employment. The Treasurer discussed the staff accountant and concerns regarding his absenteeism. The Treasurer also discussed performance concerns regarding the new receptionist. The Treasurer also discussed the consultant missing project deadlines. The Board discussed personnel development and how the staff could transition if Treasurer Birkenmaier retired. The Board discussed a potential salary raise for the Treasurer and giving the Treasurer an answer regarding her succession plan within the next few months. The Board discussed potential candidates to replace Treasurer Birkenmaier if she retired.

5.
