This form offers no deviation or exclusion from permitting procedures and policies, local ordinances or the codes adopted by the City of Denham Springs, Livingston Parish, State of Louisiana, the Louisiana State Uniform Construction Code Council, Louisiana State Fire Marshal's office, or any other authority having jurisdiction. Work cannot start until the permit is in possession and is posted.

Any person who performs plumbing work as defined by the Louisiana Plumbing Law, R.S. 37:1377, shall possess a license issued by the Louisiana State Plumbing Board. A Master Plumber shall properly designate his employing entity to the Board. Any questions concerning compliance shall be addressed to the Board.
