Location: Somerset Golf Club

Entry Deadline: June 15, 2018

Entry Opens: April 15, 2018, online via Golf Genius

Starting Time (s): 8:00 am shotgun

**Entry Fee:** **\$540.00**/team. (\$90.00 per player) Team sign up only with one credit card.  
Entry includes: Green fees, cart, range balls, prize fund and awards luncheon.

**Eligibility:** Active, female member of an NNGA member club for 60 days prior to first day of tournament. Must be 18 years of age on the first day of tournament. Must meet amateur requirements of USGA® Rules of Golf. Verifiable USGA® handicap not to exceed 36 on competition course.

**Format:** 18-Hole Team Modified Match Play. The Club's six-person team is comprised of (3) 2-person teams. **All 18 holes must be completed.** Play shall be for **NET**. (In the foursome, the better net score of a 2-person team against the other team's net score)

**Tees:** Regular women's tees, unless otherwise specified.

**Divisions:** None. Non-flighted.

**Awards:** The prize fund will be distributed to 1/3 of the field.

**Field size:** 120 Maximum (20 teams)

### Notes:

**Second Team: Email the Tournament Chair, listed below your second team to be placed into a lottery. One day after the deadline listed above, those clubs who have submitted second teams will be put into a blind drawing for any remaining team positions. All clubs who submit a second team will be notified that they were either selected and please register online, or they were not selected. Thank you.**

**Handicap:** Determined by the most current GHIN revision, *unless otherwise specified*, with maximum 36 course handicap. *The NNGA reserves the right to reduce a player's tournament handicap before, during or after the competition.*

**Team Pairings:** Each two-person team shall keep their handicaps within a 10 stroke differential. If the differential exceeds 10, the higher handicap player's handicap shall be reduced to meet the 10-stroke differential. Team pairings will be determined by the lower handicap of each 2-person team and will be paired with closely handicapped opponents from other clubs. No club shall play another club more than once. Team contestants must be from the same club. *NNGA reserves the right for exception when Clubs submit more than one team.*

**Substitutions:** Must be made through Club's Team Captain within 48-hours of event. See Standing Rules Section 6 for complete details.

**Standing Rules:** Available on the [www.nnwga.org](http://www.nnwga.org) website. Players are responsible for knowing both the USGA® Rules of Golf and Tournament Standing Rules. *It is recommended that one person in each two-person team has played in at least one Match Play event.*
