From the South: take US 23 to I-75 north. West US-10 to Stark road exit (119). Turn right (north) and go over overpass less than one mile to Stark Road. Turn right (west) onto Wackerly. (There is a TNT sign with an arrow) Go approximately $\frac{1}{2}$ mile. TNT is the blue building (look for storage units) on the right (north) side of the road. If you come to Saginaw Road you have gone too far. CAUTION: some GPS units send to the corner of Wackerly and Stark.

From the West: take US 20 to M-30 to US 10. Take US 10 East toward Midland to Stark road exit. Turn right (north) and almost immediately turn right (west) onto Wackerly.
