ORDINANCE NO. 08-2019

AN ORDINANCE OF THE TOWN COMMISION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA AMENDING CHAPTER 4 - BUILDING AND BUILDING REGULATIONS, ARTICLE I - IN GENERAL, SECTION 4-3. TIMES OF CONSTRUCTION RESTRICTED OF THE CODE OF ORDINANCES OF THE TOWN OF JUPITER INLET COLONY IN ORDER TO AMEND THE TIMES WHEN CONSTRUCTION AND RELATED ACTIVITIES MAY BE CONDUCTED WITHIN THE TOWN: PROVIDING AUTHORITY TO CODIFY: PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE: AND FOR OTHER PURPOSES

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA, AS FOLLOWS:

<u>SECTION 1</u>. Chapter 4-BUILDINGS AND BUILDING REGULATIONS, Article I - In General, Section 4-3. *Times of construction restricted* of the Code of Ordinances of the Town of Jupiter Inlet Colony, Florida is hereby amended as follows:

Sec. 4-3. - Times for construction restricted.

- (a) Unchanged.
- (b) No person or persons shall conduct the erection (including excavation), demolition, alteration, or repair of any building or conduct any contracted labor or maintenance services such as painting or lawn or shrubbery maintenance services on weekdays, including Saturdays, nor shall any such person or persons be present at the job site, other than between the hours of 8:00 a.m. and 6:00 5:00 p.m. on weekdays, and between the hours of 9:00 a.m. and 5:00 p.m. on Saturdays.
- (c) Unchanged.
- (d) Unchanged.
- (e) Unchanged.

<u>SECTION 2.</u> Specific authority is hereby granted to codify and incorporate this Ordinance into the existing Code of Ordinances of the Town of Jupiter Inlet Colony, Florida.

<u>SECTION 3.</u> That all Ordinances or parts or Ordinances, in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

<u>SECTION 4.</u> If any clause, section or other part of this Ordinance shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way affecting the validity of the other provisions of this Ordinance.

 $\underline{\text{SECTION 5.}}$ This Ordinance shall become effective immediately upon its passage and adoption.
