
NEIGHBORHOOD SPEEDING



We continue to see speeding down Coronado Hills from the four-way stop sign at Berkman. CH/CNA has been notified of a low-income housing development to be built next to the EMS station, across from the high school. The developer is applying for a 4% Tax Credit with the Texas Dept. of Housing & Community Affairs. For

REZONING REQUEST APPROVED



On January 26th, City Council approved the vertical mixed-use (VMU) rezoning request on the first of three readings. A vote on the second (and possibility third) reading is scheduled for **Thursday, February 9th**.

Three neighbors spoke at the public hearing. Their concerns were traffic safety, loss of open space and trees, and increased flooding with added impervious cover.

Three Planning Commissioners voiced their concern. Commissioner G. Cox expressed concern about traffic safety; Commission J. Thompson expressed concern about the process of including conditions that impact the Land Development Code and may have unintended consequences; and, Commissioner C. Llanes Pulido expressed general concerns about the rezoning.

The vote was 8-1-1, with Commission Jeffrey Thompson AGAINST and Commissioner Carmen Llanes Pulido ABSTAINING.

NOTE: The best time to express your voice is when the developer submits their Site Plan.

CH/CNA will keep you informed when that occurs. Comments on the Site Plan will have the greatest impact on the progress and outcome of the project.
