1. The Port of Arlington Commission meeting was called to order at 5:00 pm by President Wilson.

Those Present: President Wilson; Commissioner Shaffer; Commissioner McGuire; Port Manager / Economic Development Officer, Peter Mitchell; Admin. Asst. Kelly Margheim; Attorney Ruben Cleaveland;

Absent: Vice President Kennedy; Commissioner Hunking

Audience: None

- 2. Public Comment on non-agenda items- None
- 3. Consent Agenda:
 - Approval of October 13, 2020 Commission Meeting Minutes
 - Approval of October 2020 Payables and Financials
 Commissioner Shaffer moved to approve the consent agenda and Commissioner
 McGuire seconded. The motion carried 3-0.
- 4. Chairman's Report:

Christmas Bonus for Staff – Commissioner Shaffer moved to give \$150 Christmas Bonus to staff and Commissioner McGuire seconded. Motion carried 3-0

5. Commissioner Reports: Commissioner McGuire said the Octoberfest went really well. He did not do a lot of advertising because of COVID-19. It was a low profile event, but the event went well.

Commissioner Shaffer congratulated Pat Shannon as the new County Commissioner elect.

Commissioner Shaffer invited Judge Mike McArthur to speak via Facetime about Frontier Advocates and CREA organization.

- 6. Discussion about moderator choice for the Willow Creek IGA between the County and the Port. Judge McArthur is the founding father of Six Rivers, but he recommends Judge Grasty with Frontier Advocates for moderating the two governing bodies. Judge McArthur state Judge Grasty will be a good, neutral, and fair moderator with eighteen plus years' experience in government. The consensus is the Port recommend Judge Grasty as moderator for the joint Port/Court meeting. The meeting does not need a mediator just a moderator to run the meeting. Attorney Cleaveland and President Wilson will write an email to the County Court suggesting Judge Steve Grasty with Frontier Advocates. The cost for Judge Grasty to moderate will be \$250.00 per day plus travel. The Port board suggest the cost be split between Gilliam County Court and the Port of Arlington.
- 7. Judge McArthur said that Community Renewal Energy Association was started by Paul Wooden who was the engineer behind Klondike One, himself and a few others. CREA is interested in Special Districts joining the organization. The energy market is quickly changing. CREA helps to keep Developers, County and City leaders, Special Districts and the public informed. CREA brings expertise and advocacy to rural communities to help install renewable energy. One example Judge McArthur gave was if the Port wanted to set up a windmill to offset energy costs that is where CREA could help with its expertise and advocacy. Judge McArthur says energy storage is so important so energy produced can be efficiently stored and put into the grid when the demand is there. CREA is forward thinking in that they are looking for ways for Cities to lessen dependencies on the grid and to more independent.

EDO Mitchell asked if there were any Special Districts involved in CREA at this time. Judge McArthur stated that there are many irrigation districts that are involved. There are around forty Special Districts involved. EDO Mitchell asked what the cost would be to join and Judge MacArthur said it would be about \$100 a year at this time.

Commissioner Shaffer moved to approve Resolution 2020-147 authorizing the Port of Arlington to enter into an Intergovernmental agreement under ORS Chapter 190 Creating an association to promote, foster, and advance community based renewable energy, to be known as Community based Renewable Energy Association (CREA). Commissioner McGuire seconded. The motion carried 3-0

8.0 EDO

8.1 EDO Mitchell handed out a map for Bathroom Project and Island Park showing the latest subtle changes in the site plan including where pea gravel will placed at the old ferry landing. Engineering documents should be available for the next Port meeting.

EDO Mitchell explained to the Board that Bill Rosenbalm talked with him about hosting a bass fishing tournament in the spring. The tournament organizers were looking for funding to cover some of the cost of producing the event. The tournament is filmed and shown on several TV channels. The budget officer indicated that the Port has extremely limited discretionary funding at this time. EDO Mitchell suggested that Bill go to the County Court for funding. The tournament would bring a lot of business to local economy.

EDO Mitchell sent a proposal into Business Oregon for a substantial plant facility. The project would create approximately one hundred jobs. The Port is working with the City of Arlington as the company might need more acreage than the Port has to offer or want to purchase industrial property.

EDO Mitchell applied for an aviation grant for engineering for the Arlington Municipal Airport for the City.

EDO Mitchell has been in discussions with American Cruise lines about putting in a dock west of the grain elevator. The vessel is 300' and cannot make it into the Port marina and seek a terminal on the river side of Island Park. At this time the Port can accommodate up to a 150' vessel in the marina. American Cruise lines have their staff engineers working on a drawing.

EDO Mitchell has been working with a manufacturer and the Army on test a site for a landing craft. The testing will be in the spring of 2021. The vessel will need to dock for a couple of weeks during test and will need services for the vessel.

EDO Mitchell sent an email to the County Court stating his concerns over the RRED ZONE (Tax Exempt Zone) for solar projects. EDO Mitchell asked the County Court to reconsider allowing the RRED ZONE in Gilliam County at their November 18, 2020 meeting. EDO Mitchells' understanding is that Avangrid Renewables will need a decision by the end of this year if it is to build the project

in Gilliam County. If the economics do not work, Avangrid Renewables will pull the project. and the County will receive zero taxes ever The RRED zone allows for tax abatement for the first three years of the project and then a negotiated tax for years 4 and 5 before the solar project is taxed as a utility.

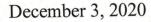

Dear Port of Arlington:

This letter is to inform you of an opportunity available to our region for improving the local economic base, business climate, and long-run community development. Gilliam County is furthering this opportunity by seeking designation of a rural renewable energy development zone ("RREDZ"), which functions like an enterprise zone throughout the County's territory for renewable energy projects such as wind power projects, geothermal, or other cases where a renewable energy resource is used to generate electricity or to produce a biofuel.

The request to designate a RREDZ will be submitted to Business Oregon for approval. At a public meeting on Thursday, December 17, 2020 at 5:30 pm, via Zoom, the County Court will consider a resolution requesting designation. Adoption of the resolution, however, will not occur until on or after December 24, 2020. During these meetings, the County will accept feedback on the resolution and designation of the RREDZ.

You are receiving this letter because your agency either receives, or has the authority to receive, revenue from the ad valorem taxation of property. The proposed area for the RREDZ is countywide by statute, such that the zone could affect future property tax collections in your district. Therefore, you are being asked to comment on this proposal, either at the meetings noted above or by sending comments to either Commissioner Sherrie Wilkins or Commissioner Leslie Wetherell, by December 24, 2020.

Please understand, that a RREDZ exempts only new property that an eligible, job-creating business might build or install in the zone at some future time. Also, the exemption is temporary, usually lasting only three years, after which time the property induced by these incentives is available for assessment. An extension to four or five years in total is possible in some cases with agreement of the County's governing body.

The Port Board met and considered the suggestion to use Six Rivers to moderate our proposed meeting regarding Willow Creek. While the Board appreciates Six Rivers potential abilities as a mediator, it seems that a moderator is really what is needed. This proposed meeting is a joint public meeting which requires a designated chairperson to preside over the meeting. It is not likely that a mediator is going to have the governmental experience to run a public meeting. As an alternative, the Board has contacted Frontier Advocates and they recommended Judge Steven Grasty from Harney County to chair/moderate the meeting. Judge Grasty has a lot of experience presiding over public meetings, working on public policy on behalf of rural communities. He understands the public meeting process. Administration

The Port took advantage of an Energy Trust grant to replace the office's florescent and incandescent light fixtures with energy efficient LED fixtures. Port maintenance staff has also done an excellent job in painting the Port's interior office space. This effort is bringing in a new look for a new year. Welcome 2021!

Economic Development

Alpine Power Systems has leased the entire Flex building. The company signed a two-year lease with a 1-year option for the entire facility. Welcome Alpine Power Systems and team to the Port of Arlington.

Island Park

The Malt Plant siting feasibility and cost estimates for a proposed plant are pending. The proposed plant will be approximately 14,000 square feet and produce craft malt for the brewers and distillers. The plant will be located on Island Park.

American Cruise Lines has expressed interest in locating a permanent docking facility at the Port's Island Park. The passenger cruise line anticipates landing 300 passengers per week in Arlington as part of their Columbia River tour packages. Port staff is working with American Cruise Lines and Marine engineers to develop a cruise ship dock design and permitting plans.
