SECTION I

Definitions

Definitions as set forth in Article 14-H, Section 476 of the General Municipal Law of the State of New York are incorporated in this Local Law and made applicable hereto as if more fully stated herein. fully stated herein.

SECTION II

License Requirement

Subject to the provisions contained herein, the rules and regulations of the State Bingo Control Commission, the provisions of Article 14-H of the General Municipal Law of the State of New York, the provisions of Article 19-B of the Executive Law of the State of New York, and the Constitution of the State of New York, and all amendments of the aforementioned statutes, rules and regulations, it shall be lawful for any authorized organizations, upon obtaining a license therefore, under the provisions of this Local Law, to conduct the game of Bingo within the territorial limits of the Village of Cohocton, New

SECTION III

Authorized Games Permitted

No person, firm, association, corporation or organization, other than an authorized organization, as defined, licensed under the provisions of this Local Law, shall be permitted to conduct such games.

SECTION IV

Proceeds of Game

The purposes of entire net proceeds of any the organization permitted game shall be to conduct said said game. exclusively devoted ç the lawful

SECTION V

Single Prize

No single prize shall exceed the sum or value of Two Hundred Fifty Dollars (\$250.00).

SECTION VI

Series of Prizes

No series of prizes on any one occasion shall aggregate more than One Thousand Dollars (\$1,000.00).

SECTION VII

Management of Game

No person except a bonafide member of any such organization permitted to conduct said game shall participate in the management or operation of such game. No person shall receive any remuneration for participating in the management or operation of such game of Bingo.

SECTION VIII

Controlling Provisions

The provisions of Article 14-H of the General Municipal Law, and any amendments thereto, shall control the licensing of organizations and the conduct of games of Bingo in the Village of Cohocton, New York and this Local Law incorporates the provisions of Article 14-H of the General Municipal Law by reference herein as if more fully stated.

SECTION IX

Unauthorized Games; Penalty

Any unauthorized conduct of the game of Bingo and any willful violation of any provision of this Local Law shall constitute and be punishable as a misdemeanor.

SECTION X

Effective Date

This Local Law shall take effect immediately following the approval of the same by majority of the qualified voters voting on said proposition at a general or special election.
