<u>25/01732/FUL</u> The Stables, Brockhill Quarry. Erection of a permanent equestrian manager's dwelling. Permitted.

<u>25/01509/FUL</u> Land and building east of 3 Littlesworth. Erection of self-build two-storey dwelling and detached garage, demolition of dilapidated barn. Naunton Parish Council did not object to this application. Highways Officer has recommended refusal. Conservation officer accepts modifications and recommends permission with conditions.

24/01956/CLEUD 1 Aylworth Cottages The applicant has taken this to appeal. Still no date available. Written appeal only. Case officer stated that the applicant has failed to provide 'sufficiently precise and unambiguous information' for a CLEUD'. Final comments received May 25. Awaiting decision.

25/00502/FUL Roundhill Farm, Lower Harford GL54 3AQ. Change of use from agricultural outbuilding to holiday let, extension and associated works. Permitted with 13 conditions. 25/02145/FUL Lavender Hill Farm. Erection of agricultural building to form cover over existing solid manure heap. Biodiversity Officer has approved provided applicant submits a woodland protection plan and a 10-year Landscape and Ecological Management Plan. Permitted.

- 10) Neighbourhood Development Planning. Clerk attended several information sessions regarding Neighbourhood Planning. Due to the increase in the number of houses that the Government has stated that CDC has to build, speculative application are expected from developers. The CDC local plan is now deemed outdated but the regulations protecting the AONB/CNL in the NPPF remain. Some Neighbourhood development plans can take many years to complete and cost many thousands. The aim is to set out local residents' needs and ensure these are met as far as possible by the planning authority. A number of potential development sites have been identified in Naunton but, together with the NPPF regulations, the number of new houses would still be low. If Naunton does not feel that residents would be unhappy with a small numbers of new homes, then there is no need for an NDP. Other, less weighty, approaches to local planning will soon be available. Details will be discussed when available. CPRE recommends addressing any and all planning issues actively. The Recreation field is already registered with Sport England. Further protection could be provided through registering it as a 'Field in trust' or as a Local Green Space in the CDC Local Plan, currently being drafted.
