## Housing and Urban Development - Irene Cantrell reported.

- CDBG 2020 On November 19<sup>th</sup> the Engineering Firm advised that they will be submitting the McLeod S/D Sewer Improvements Plans to LPSS packages to EPD and GSWCC for their approvals.
- 2. **BZA** The BZA Board met on Tuesday, November 30, 2021, to consider a variance / permit request from Ms. Jackie Walker, to locate a new 2021 single-wide manufactured home at 1106 North 10<sup>th</sup> Street, Northside Addition, Block C, Lot 27, Cordele, Georgia. This area's Zoning designation is (R-4), Multi-Family Residential District. There were no persons present at the public hearing to object to Ms. Walker's request to locate a manufactured home at 1106 North 10<sup>th</sup> Street.
  - The Board of Zoning Appeals voted unanimously to recommend to the Cordele City Commission that this request be granted to Ms. Jackie Walker to locate a single-wide manufactured home at 1106 North 10<sup>th</sup> Street, Cordele, Georgia.
- 3. CPC The Cordele Planning Commission met on December 2, 2021, at 10:00 a.m., for a scheduled public hearing and a public meeting on an annexation / zoning request from Wells Properties, LLC (Mr. Chip Wells). The subject property is located at 1303 and 1305 East 16<sup>th</sup> Avenue / Highway 280 East. Also known as Land Lot 9 of the 11<sup>th</sup> Land District, Crisp County, Georgia, containing 2.373 acres. The requested zoning classification is Highway Commercial District (HC).
  - There being no objections from the public during the public hearing therefore the Cordele Planning Commission members voted unanimously to approved the annexation / zoning classification as Highway Commercial District (HC) be recommended for approval by the Cordele City Commission.

#### Police Dept. Capt. Jalon Heard reported:

- We are in the process of removing the front window tint from our patrol vehicles. This
  will be one step in the community and patrolman developing positive relations.
- We are exploring a change in uniforms. The current uniform looks too tactical. We are going to move the equipment back to the belt and provide a more professional appearance.
- We have updated our traffic stop policy. This change provides a more professional
  interaction with citizens during a routine traffic stop. We monitor these interactions via
  our body camera videos, and hold the officers accountable. (Take some copies of the
  directive I sent out)
- We are encouraging the officers to interact with the community, particularly in the neighborhoods, when calls for service slows down. We understand this is the primary way for us to build quality community relationships. We will be tracking the number of contacts to hold the officers accountable.
- We are working with Cordele Housing Authority to begin community meetings in each complex. This will provide a way for citizens to speak directly with the police and voice their concerns about issues that affect them.
- Our investigative unit is meeting, working, and communicating with CCSO investigators
  to share information. Many of our offenders are well known to both agencies. This
  sharing of information is beneficial in so many ways. The Sheriff has been very
  supportive in our efforts to fight crime that crosses over in the county.
