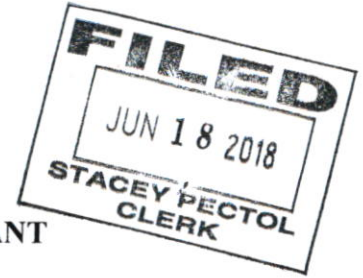

JURISDICTION

This Court has jurisdiction pursuant to Rule 2-1 of the Rules of the Arkansas Supreme Court. Appellant invokes all other pendent jurisdiction of this Court.

FACTS

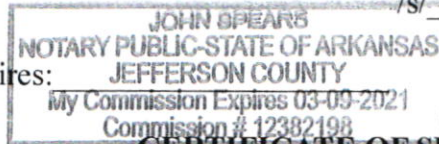
On January 18, 1997 Heath Stocks was charged with three (3) counts of Capital Felony Murder in the Lonoke County, Arkansas. (*R.pg.1.; Add.;pg.104-05*). Stocks signed a guilty plea agreement form on June 5, 1997. (*R. pg.48; Add.; pg.5*) On June 6, 1997, Lonoke County Circuit Court Judge Lance Hanshaw signed a judgment and commitment order sentencing Stocks to three (3) consecutive life without parole sentences in the Arkansas Department of Corrections.

1. One September 21, 2017, Stocks filed a Motion/Petition for the Issuance of the Writ of Error Coram Nobis in the Lonoke County Circuit Court. (*R. pg. 65; Add. pg. 39-100*).
2. The State filed a motion on September 21, 2017 to seal the Motion/Petition for the Issuance of the Writ of Error Coram Nobis due the child sexual abuse and confidential information relating to child rape and sex abuse victims. (*R. pg. 631; Add.; pg. 606-607*)
