#### **VETERAN CLASSES**

Veteran Dogs and Bitches - 7 yrs. & older
At Independent Specialties Neutered dogs and Spayed bitches may compete.
The winners of these classes will compete for Best of Breed

**COURSING:** for Salukis that are AKC registered and are confirmed AKC or ASFA Field Champions, Coursing Champions or Coursers of Merit. Exhibitors must supply proof of title at time of entry. (A copy of the certificate awarding the title, or a copy of the entire page from either the AKC gazette or FAN magazine publishing the title, will be accepted as proof.) First place winners in this class are eligible for Best of Breed competition, providing all AKC eligibility requirements have been met, and providing dog is undefeated in any other class.

Winners of the above classes are eligible for Best of Breed competition.

#### NON-REGULAR CLASSES

(Multiple Dog Entries)

**STUD DOG CLASS:** For Stud dogs and no more than two (2) of their Get. Get must be entered in a regular class at this show. The award is based on the merit of the Get. The Stud dog must appear in the ring with the Get and be entered in this show. Stud dog may be neutered. The owner of the Stud dog does not need to be the owner of the Get. Stud dog and Get comprise one entry.

**BROOD BITCH CLASS:** For Brood bitches and no more than two (2) of their Produce. Produce must be entered in a regular class at this show. The award is based on the merit of the produce. The Brood bitch must appear in the ring with the Produce and be entered in this show. Brood bitch may be spayed. The owner of the Brood bitch does not need to be the owner of the Produce. Brood bitch and Produce comprise one entry.

BRACE CLASS: Shall be two (2) Salukis, regardless of sex, with at least ONE owner the same. At least one of the Brace must be entered in a regular class, Best of Breed, or in a non-regular class other than Brace. Those desiring to show in Brace class must write "BRACE" on the entry form in the space provided for "Additional Classes". If more than one Brace is entered by the same owner, the dogs comprising each Brace must be designated as "Brace #1", "Brace #2", etc. Spayed or neutered dogs may be entered in this class.

**EXTENDED GENERATION CLASS:** Entry must be made up of a minimum of 3 generations of Salukis with one descendant from each successive generation, i.e. Dogs A, B, C. A is the sire/dam of B. B is the sire/dam of C. Only two representatives from each generation are allowed. Judge's decision is to be based on merit and likeness of Get/Produce. Off spring must be entered in a Regular Class, Non-Regular Class or Best of Breed competition. First place only will be awarded in this class. **A separate entry form must be submitted for each dog entered.** 

Winners of the above classes are not eligible for Best of Breed competition.

#### JUNIOR SHOWMANSHIP

#### FREE

**NOVICE JUNIOR CLASS**: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show. **NOVICE INTERMEDIATE CLASS**: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

First Places, with competition present, in a Novice Class at a licensed or member show. **NOVICE SENIOR CLASS**: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS**: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS**: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS**: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

MASTER CLASS: This class will be for Boys and Girls who are at least 9 years and under 18 years of age on the day of the show, and who have won the 10 First Place wins in an Open class, with competition, to be eligible to enter the AKC National Championship competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry on the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

#### **BITCHES IN SEASON ARE NOT ELIGIBLE**

**ALL JUNIOR HANDLERS ARE REQURED TO HAVE AN AKC NUMBER** PRIOR TO THE DAY OF THE EVENT. Numbers may be obtained from the American Kennel Club, call (919) 816-3776. Junior handlers must put their nine digit number on the entry blank. Be sure to include all information required on both the front and back of the official AKC entry form.

#### **PUPPY/VETERAN SWEEPSTAKES**

#### **Entry Fee \$15.00**

- The Sweepstakes judging will take place before regular judging
- Puppy Sweeps entrants **MUST** be entered in a regular class

#### **DIRECTIONS TO THE SHOW SITE**

From I-10: Take I-10 to US 60 East. Take Exit 182 for Gilbert Rd. Go North on Gilbert for 2 miles. Turn Right (East) onto Southern Ave. Turn North on Lindsay Rd and go appx 6  $\frac{1}{2}$  miles. Royal Arabians will be on your Left.

From I-17: Go South on I-17 to Loop 101 East exit. Continue on Loop 101 to Loop 202 East exit. Proceed on Loop 202 for appx 6 miles. Take Gilbert Rd exit and proceed South on Gilbert. Turn Left (East) on McKellips Rd. Turn Right (South) onto Lindsay Rd. Royal Arabians will be on your Right.

#### PEE WEE CLASS

## FREE - Sunday only

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- The safety of both the dogs and Juniors inside and outside the ring is a primary concern. A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- There is a separate entry form for the Pee Wee class below. In addition to an entry form, a release must be signed by the child's parent or legal guardian. These must be sent together and received by close of entries.
- At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

#### Pee Wee Class Release of Liability

In consideration of being given the opportunity to participate in the Pee Wee Class at the \_\_\_\_\_ Club ("Club"), I, for myself, my personal representatives, assigns, heirs, and next of kin and I, the minor's parent and/or legal guardian.

1) acknowledge, agree and represent that I understand:

- a. the nature of the Pee Wee Class:
- b. that a Responsible Adult will accompany the minor in participating in the Pee Wee Class;
- c. I selected the Responsible Adult or am the Responsible Adult;
- d. the minor's experience and capabilities to be qualified to participate in the Pee Wee Class:
- e. the dog's propensities, size and maturity;
- f. I have selected the dog to participate with the minor AND
- g. All parties are qualified to participate in the Pee Wee class
- 2) fully understand:
- a. The Pee Wee Class involves risks and dangers of serious injury;
- b. These risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Pee Wee Class, the conditions in which the Pee Wee Class takes place, or the negligence of the Releasees named below;
- c. There may be other risks either not known to me or not readily foreseeable at this time AND
- d. I fully accept and assume all such risks and all responsibility for losses, costs, and damages I or the minor child incur as a result of our participation in the Pee Wee Class.

I hereby release, discharge and covenant not to sue the Club, the American Kennel Club. Inc., their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties and any AKC approved judge, judging at this event ("Releasees") from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise; and I further agree that if, despite this release and waiver of liability, assumption of the risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim, to the fullest extent permitted by law. If any portion of this release from liability shall be deemed by a Court of competent jurisdiction to be invalid, then the remainder of this release from liability shall remain in full force and effect and the offending provision or provisions severed here from. Additionally, I and the minor child hereby assume the sole responsibility for and agree to indemnify, defend and save the Releasees harmless from any and all loss and expense (including legal fees) from any liability, claim, demands, losses or damages which may be alleged to be caused directly or indirectly to any person or thing by the act of this dog while in or about the premises or grounds.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

THESE SHOWS are governed by The American Kennel Club. Exhibitors should read the AKC agreement on the back side of the entry blank in this Premium List.

ENTRIES NOT ON OFFICIÁL AKC E NTRY FORMS and Photocopies of entry Forms without Agreement and Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE. NO ENTRY CAN BE ACCEPTED that specifies any conditions as to its acceptance. Telegraph or unsigned entries cannot be accepted. Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in the event of errors after closing date.

ENTRY CONFIRMATIONS & JUDGING PROGRAMS will be **e-mailed** to all entrants who provide email addresses. All others will be mailed by the USPS.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring. There is no provision for unentered dogs at this show.

THE CENTRAL ARIZONA SALUKI ASSN & THE SALUKI LEAGUE OF SOUTHERN ARIZONA may

decline entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or any other cause. No one shall have any claim or recourse against he Club or any official thereof

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, sick, lame, excused by Veterinarian or Judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. If, because of riots, civil disturbances or other acts beyond the control of the management, it becomes impossible to open or complete the show, no refund of entry will be made. There is no refund of entry fee for duplicate entry. There will be a \$2.00 fee charged for cancellation of entry prior to closing of entries.

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Show Secretary will add a \$35.00 collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.



It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the Show premises. And, in addition, no responsibility will be assumed for any loss, damage or injury sustained by an owner, exhibitor, handler or spectator. The welfare of an exhibitor's child is the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control and restraint over their children at all times.

DOGS MAY ARRIVE at any time prior to scheduled time of judging of their class. Dogs not required for

Owners or handlers alone are responsible for the presence of their dogs in the judging ring. There is no rule of this Club or the AKC that requires a Judge to wait for a dog. TROPHIES AND CLASS CASH PRIZES will be awarded in the judging ring to the person showing the dog. In the event of any discrepancy from the published prize list, the Show Chairman should be advised at once. All trophies must be claimed the day of the show. None will be mailed.

RECORDING & EVENT FEES: A Recording Fee of  $50\phi$  per dog and an Event Services Fee of \$3.00 will be required for each entry at any Licensed or Member Club Show, Obedience Trial or Tracking Test. These fees are to be collected by the Show-giving Club and paid to the American Kennel Club. (AKC Rule, Ch 11, Sec 2)

TRANSFER OF ENTRY TO BEST OF BREED: Dogs which according to their owner's records have completed the requirements for a Championship after the closing of entries for the Show but whose Championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Show Secretary at least one-half hour prior to the start of the earliest conformation judging at the Show.
