MESSAGE FROM OUR LEADERSHIP

Dear Friends of the Lloydminster and District SPCA,

It has been an exciting year of growth and development for the Lloydminster and District SPCA. Once again, we had a record breaking adoption year, with 619 animals finding their forever homes. Even more remarkable is that 461 of which were cats and kittens.

In 2016, we continually strived to improve the quality of care for the stray and homeless animals at the shelter, with the implementation of a managed admissions program, enabling us to more effectively monitor our intake numbers. Based on industry best practices, we also increased the size of our cat kennels, which has resulted in happier and healthier animals who are spending less time in the shelter before being adopted.

For the second year in a row, we saw a dramatic increase in the number of stray cats and kittens admitted to the SPCA. Sadly, many of these cats have no identification, making it difficult to reunite them with their families. In fact, this year, only 7% of cats were reclaimed.

To help improve the chances of these cats finding their way home, the Lloydminster and District SPCA, in partnership with Weir Veterinarian Services, Lloydminster Animal Hospital and Southside Veterinarian Clinic, offered a 'Microchip your Cat' Initiative from May 30 – June 4. During this promotion, cat owners could take their cat to the veterinarian to receive a microchip, by donation. Over 30 cats were microchipped during this week and it is our goal is to make this an annual program.

This year, one of our main objectives was to be more actively involved in our community and to share the message of compassion and respect for all animals. In addition to our annual fundraisers, Team SPCA participated in variety of events throughout the year including 'International Hug Your Cat Day' and 'Take a SPCA Dog to Work Day' events. We also participated in the Colonial Day Parade and the Parade of Lights.

We continued to expand our education programs this year, including the forming of our first official Kid's Club at St. Joseph Elementary School. In October 2016, we launched our Book Buddies program, which encourages children ages 5 to 13 to develop their literacy by reading to the shelter animals.

Our success in 2016 could not have been achieved without the dedication and hard work of our staff, volunteers and members of the community. We are truly fortunate to serve the City of Lloydminster and share in our commitment to building a community where animal welfare is a priority. Together we are making a difference.



ADOPTION HIGHLIGHTS

- 619 animals were adopted to their forever homes, breaking our previous record set in 2015
- 461 cats were adopted, the most in 7 years
- In 5 separate months, adopted over 50 animals
- Various adoption days at our satellite adoption centres
- We held 4 cat adoption promotional events this year, adopting out 167 cats
- Participated in first Province Wide 'Empty our Shelter' adoption weekend adopting 35 animals




LONDYN, BOYER & GOLF CART ADOPTED TO THE SAME FAMILY ON THE SAME DAY




ADMISSION HIGHLIGHTS


- 1128 animals were admitted to shelter
- Increase in cat admissions due to two mild winters
- Continued decrease in dog admissions




- 901 stray animals admitted
 - o 233 were impounded by local area by-law enforcement
 - o 159 of which were impounded by City of Lloydminster Bylaw Enforcement
- 214 animals were Owner Surrenders




- 355 stray dogs were admitted
 - o 194 were admitted by citizens
 - o 161 were admitted by Bylaw Enforcement



• 112 dogs were admitted by City of Lloydminster Bylaw Enforcement




- 537 stray cats were admitted
 - 454 were admitted by citizens
 - o 83 were admitted by Bylaw Enforcement
 - o 74 of which were admitted by City of Lloydminster Bylaw Enforcement
- 128 were admitted to the shelter by their owner
 - o 56 cats and 24 kittens from a hoarding situation




RETURN TO OWNER HIGHLIGHTS

- 244 stray dogs were reunited with their owners, this is almost 70%
- Less than 7% of stray cats were reclaimed by their owners
- 777 City of Lloydminster licenses sold in 2016, 183 cat licenses and 594 dog licenses



LIVE RELEASE RATE

- 415 dogs were either adopted, reclaimed or transferred to another animal organization
- 559 cats were either adopted, reclaimed or transferred, the most in 7 years
- 88% of animals that were admitted were either adopted, transferred or reclaimed
 - Decrease in live release rate compared to 2015 due to euthanasia of cats from hoarding situation
 - o If these totals removed, live release rate would be 92%



MEDICAL

- 272 spays and 270 neuters where completed at our partnering vet clinics in 2016 for a total of 542 altered animals
- Completed 10 leg amputation, 1 FHO surgery, and 3 dental procedures
- Staff member, Taylor Budding, completed her Registered Veterinary Technician
- Continued partnership with the Lloydminster Animal Hospital for the daily medical needs

HIGHLIGHTS AND SUCCESSES

- January 2016 Implemented Managed Admissions Program based on Capacity for Care standards
- February 2016 Joined Society of Animal Welfare Administrators
- April 2016 Attended Canadian Federation of Humane Societies Conference in Toronto
- May 2016 Enrolled in shelter privilege program with Royal Canin
 - Earn points that toward free food for the animals in our care, to date we have received a total of 1500lbs
- May 2016 Provided support to pet owners fleeing Fort McMurray Wild Fires
- August 2016 Founding member of the Saskatchewan Federation of Humane Societies
- September 2016 Attended the Saskatchewan SPCA Conference in Saskatoon
- November 2016 Partnered with PetValu Lloydminster as Satellite Adoption Centre
 - o In the first 2 months we adopted 7 cats from their location
- Throughout 2016 Providing housing for 3 pets as part of the Pet Safekeeping Program

 October – December 2016 - Added portals to our cat kennels doubling the size to increase quality of care

VOLUNTEER PROGRAM

- Over 100 volunteers contributing more than 1200 hours

- Several corporate groups visited the SPCA to help with various duties and to spend time with the animals

FUNDRAISING

- Raised over \$36,000 in public donations
- Raised over \$48,000 in business donations
- Received a donation of \$50,000 from the RJ Nelson Family Foundation
 - \$25,000 for our Spay/Neuter Program
 - o \$25,000 for our Barney's Wish Emergency Medical Fund



- Received a donation of \$12,165 from Husky Has Heart Community Initiative program for our Spay and Neuter Program
- Received donations of supplies and services from various businesses and communities including Lakeland College, Children's Birthday and Local Clubs

DONOR PROGRAMS

In 2016, the Lloydminster and District SPCA introduced four new donor programs: Support the Paws Monthly Giving Program, Barney's Wish Emergency Medical Fund, Gifts for Paws and, Sponsor an Adoption Program

MONTHLY GIVING PROGRAM

- For just cents a day, donors provide valuable support to the stray and homeless animals we care for
- Donors choose the amount you would like to contribute monthly



- Donors receive a tax receipt at the end the year for their contribution
- Raised over \$3,600 in 2016

BARNEY'S WISH EMERGENCY MEDICAL FUND

- Program named in honour of Barney, who had to have his leg amputated due to an injury from a bullet wound
- Donations to program support those animals that require additional medical care or surgery
- In 2016, 10 animals received leg amputations



GIFTS FOR PAWS

- Donors choose where they would like their donation to go
- Donations to program provide essential services and supplies including spay or neuter surgery and vaccinations

SPONSOR AN ADOPTION PROGRAM

- A great opportunity for individuals or companies to support the SPCA
- Donors can choose the animal they would like to sponsor
- Donors receive an update informing them when their sponsored animal has been adopted

SPECIAL EVENTS

The Lloydminster and District SPCA held four major fundraising events this year.

- Moved to a new venue, Rolling Green Fairways
- Lower ticket prices, which resulted in a sold out with 285 tickets sold
- Raised \$6,869.57

HOGS FOR DOGS

- Partner with Bordertown HOGs
- 36 riders participated
- Raised \$1,609.77

SPCA DINNER THEATRE

- Another huge success
- 3 sold out nights and one night over 75% sold
- Increase in money raised compared to 2015

- Majority of donations made online
- Increase in donations compared to 2015
- Raised \$24,617.25
