**The tournament will be operated under strict compliance with TNBA and USBC rules (see additions and/or exceptions below)**

- HANDICAP** for this Tournament will be **100% of 840 based on team average. Multiple participation allowed. Repeat teams must change at least one bowler.**
- Bowlers must use the higher of: (a) 2018-2019 book average of 21 games or more; (b) 2017-2018 book average of 21 games or more; **If no book average for the last two seasons, bowler must use 210. USBC rules 319a-2 is waived for this tournament. Rules 319a-3 and 319e apply. Summer averages and Sport Averages will not be allowed.**
- Professional Bowlers (PBA/PWBA) regardless of classification will not be permitted to bowl in So Cal Tri-Senates tournaments
- Women entering with a 139 or less average or Men entering with a 159 or less average will be handicapped at 140 for women and 160 for men. **This applies for handicap purposes only and does not apply toward the team maximum average! This also applies for all Optional Events**
- Any entrant having been re-rated or subject to re-rate by another tournament must report their re-rated average to the tournament director prior to bowling, failure to do so will result in disqualification**
- No headgear allowed during tournament play.  
Substitutes will be allowed. Once a substitute starts to bowl, he/she must complete all five games. **All substitutions/and or changes must be made at the Official Change desk before the start of each squad or they will not be accepted. There will be no changes made on the lanes.** Bowlers may not annotate the official recaps in any manner other than to enter scores.
- NO REFUNDS.** Fees after being received will not be refunded except in dire emergency, such as an employees strike, employees lockout, fire, acts of God, or anything else management has no control over
- All participants must wear a **TNBA** shirt of their choice for all squads..
