
Meet our new BLCA board members, Cont'd:

President's Letter

Late Winter (or is it early spring?) Greetings!

By the time you read this, the icehouses will be off the lakes and "Frostbite City" will be a day camp. The directories have been distributed and, if you were missed, it was probably because the snow on your property suggested you were a snowbird. Don't worry; you can grab one at the Briggs Lake Store and other places!

I hope all of you have taken advantage of the opportunity to become a 2013 BLCA Member. If you misplaced the mailing, log onto the BLCA website (briggslakechainassociation.com), select 'membership' from the left-hand menu, and download a membership form. The membership (tax deductible!) donation amount and the address to mail the completed form are on the document. This mailing goes out to more than lakeshore residents and each of our four lakes has a public landing. Winter and summer our lakes are enjoyed by many more than just the people lucky enough to live beside them. They are a community resource and we all can enjoy them and have an interest in protecting them. If you are at all interested in protecting and fixing our lakes, please feel free to join the BLCA and/or donate to BLCA projects.

BLCA volunteers have been busy this winter preparing for this spring. Six volunteers and two members of Sherburne Co. SWCD were trained to take samples of lake water through the ice. They braved -12° temperatures during the outside sampling session to be able to sample water near sites adjacent to properties that were marked as suspicious during the winter flyover. Testing these samples will help validate concerns on these properties and determine what recommendations are necessary. The Game Night fun event was again enjoyed at the Town Hall.

Volunteers have been seeking grants and donations from organizations for curlyleaf pondweed spraying, volunteer training, making recommended flyover changes on properties to keep runoff and pollution from entering our lakes and other BLCA activities. Groundtruthing will resume after ice off. A SERP Workshop is scheduled April 20th for property owners seeking grants to implement flyover shoreline recommendations. Late-spring more groundtruth volunteers will be needed. If you are interested please notify me via the website (briggslakechainassociation.com) and select 'contact.' I will make sure you get added to the list of volunteers. You will need to be trained and make a one-year commitment to groundtruthing. You will learn a lot, meet new people, view the beauty of our lakes from unique vantage points and help fix our lakes.

Thank you for supporting the BLCA with your membership, curlyleaf pondweed and Big Elk walleye stocking donations.
