RE: Nashua Airport Hangar Facility Available for COVID-19 Vaccine Administration
Building Address: 9 Perimeter Road, Nashua Airport, Nashua, NH
Interior Hangar Space: 14,000 Sq. Ft.; plus 800 Sq. Ft. Office and Restrooms

Dear Governor Sununu,

The purpose of this letter is to offer the use of our Aircraft Hangar facility at Nashua Airport in support of your Administration's COVID-19 vaccination efforts. Our facility, located at 9 Perimeter Road, Nashua Airport, has street-side access and can accommodate several vehicles at a time inside the hangar as a vaccine-administration location.

I understand the Nashua Airport Authority (NAA) is also issuing a letter in support of vaccine deployment efforts at Nashua Airport, subject to considerations and constraints unique to the airport and its regulatory and security environment. This letter should be read as complementary to the NAA's Letter and subject to the Authority's jurisdiction. Temporary authorization from NHDOT to make use of the aircraft hangar (although privately owned) for non-aeronautical purposes will also be required.

The Hangar (we refer to the hangar as 'Building 9' due to its address at 9 Perimeter Road) has (100' x 30') sliding hangar doors that can be opened for ventilation; and room exists, if needed, for the location of vaccine-storage refrigeration units within the building. As the letter to you from the Chairman Woods of the NAA indicates, street-side access is available through a Perimeter Road vehicle entrance that will not interfere with airside aircraft traffic or movement. Office and restroom facilities are available in the hangar for staff needs. Portable rest facilities will be needed for public use. (An aerial overview of the building and local airport environment is attached for your reference).

Coordination with the Nashua Police Department and/or NH National Guard or other law-enforcement and the Nashua Airport Authority through its capable Chairman, Farrell Woods, and Airport Manager, Chris Lynch, for vehicle staging, traffic management and airport security will be essential to ensure there is no impact to ongoing Airport business operations and motor vehicle traffic. While Perimeter Road is not well-suited to vehicle waiting or standing, I understand efforts are underway to secure permission to use ample parking available at the former Daniel Webster Campus parking lots located nearby and adjacent to the Airport for this purpose.

A method for metering traffic to and from Building 9 will be important to avoid Perimeter Road congestion. This will become easier as experience is gained with the logistical requirements of this location, and a manageable vaccination rate is established.

Thank you for your leadership on behalf of the citizens of the State of New Hampshire, we look forward assisting in any way we can.
