## AN ORDINANCE OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AUTHORIZING THE SALE OF A 1978 FORD BOX VAN OWNED BY THE VILLAGE OF CHAPIN, ILLINOIS

WHEREAS, in the opinion of the Corporate authorities of the Village of Chapin, Illinois, it is no longer necessary or useful to or for the best interests of the Village of Chapin, Illinois, to retain ownership of the following personal property: a 1978 Ford Box Van, Serial # CJ1340; and

WHEREAS, the Corporate Authorities of the Village of Chapin, Illinois, deem it advisable to sell said motor vehicle to Mary Ward of Bethe, Illinois, for the sum of One Thousand Dollars and 00/100 Cents (\$1,000.00).

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS:

SECTION 1: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find that the 1978 Ford Box Van, Serial # CJ1340, now owned by the Village of Chapin, is no longer necessary or useful to the Village and the best interest of the Village will be served by its sale.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President is hereby directed to take all necessary action to sell the 1978 Ford Box Van to Mary Ward of Bethel, Illinois, for the sum of One Thousand Dollars and 00/100 Cents (\$1,000.00) and to transfer title and ownership to the vehicle to Mary Ward.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
