## PAYING YOUR PROPERTY TAXES

### TAXES ARE DUE OCTOBER 5, 2025

**Our EXTENDED HOURS will be until 6:00p.m. on October 6<sup>th</sup> without any fees or penalties.**

**After 6:00pm October 6<sup>th</sup>, 2025, an 8% penalty and 1 % interest will be applied**

There are several ways you can pay your property taxes:

- **CASH** – in person at the Town Clerk’s Office
- **CHECK** – made payable to the Town of Lowell.  
These can be mailed to 2170 Vt Rte. 100 Lowell, VT 05847 or dropped off in the mailbox outside the office  
**\*\*\* (Our office will be closed October 5<sup>th</sup>; you may drop your payment in the mailbox outside our office or wait until Monday Oct. 6<sup>th</sup> with no penalties) \*\*\***
- **CREDIT CARD** – Online and in office  
**A service fee for credit cards will be charged to the cardholder - \$3 OR 2.65% (whichever is greater)**
- **PAY ONLINE-**  
**VISIT THE TOWN OF LOWELL WEB SITE AT [WWW.TOWNOFLOWELL.ORG](http://WWW.TOWNOFLOWELL.ORG)**
  - Under the “Property Tax Section” you will find a link to pay online with a debit or credit card.
  - *A service fee will be charged to the cardholder - \$3 OR 2.65% (whichever is greater)*
  - Just click the link to pay online and follow the directions. Please enter your parcel ID or your property address in the reference line.
  - Before your card is charged, the site will confirm what your service fee will be. If you do not agree, simply cancel the transaction.
  - A receipt will be emailed to you directly from the credit card processing company, or you can print one on the spot.
  - **IT IS SIMPLE AND EASY TO USE AND DON’T WORRY – YOUR INFORMATION IS SAFE AND SECURE.**
  - The Town of Lowell will be sent confirmation of your payment but will NOT be sent your card number or any other confidential information.
  - *If you have any questions about this service, or require assistance in using it, please don’t hesitate to contact us.*
