## **RESOLUTION NO.** 98 - 01

A RESOLUTION SETTING FORTH THE FINDINGS OF THE BOARD OF DIRECTORS OF THE GRAND COUNTY WATER CONSERVANCY DISTRICT RELATIVE TO THE CREATION OF THE GRAND WATER AND SEWER SERVICE AGENCY, AND AUTHORIZING THE CHAIRMAN OF THE BOARD TO EXECUTE SAID AGREEMENT ON BEHALF OF THE DISTRICT

WHEREAS, state law provides that, pursuant to the provisions of the Utah Interlocal Co-operation Act, §11-13-1, et seq., Utah Code Ann., 1953, as amended (the "Act"), any power or powers, privileges or authority exercised or capable of exercise by a public agency of the state (defined as any political subdivision of the state, including special districts of various kinds), may be exercised and enjoyed jointly with any other public agency, and that any two or more public agencies may enter into agreements with one another for joint or cooperative action pursuant to the Act; and

WHEREAS, the Grand County Water Conservancy District, the Grand County Special Service Water District and the Spanish Valley Water and Sewer Improvement District (hereinafter collectively, the "Districts") have historically shared employees and other resources in providing their respective municipal services to residents and others within their respective boundaries; and

WHEREAS the Board of Directors of the Grand County Water Conservancy District hereby finds and determines that there is mutual advantage and benefit of economies of scale, economic development and utilization of resources in cooperating with each of the other Districts in jointly planning, financing, operating and maintaining the resources and assets of the Districts in and for the common interest and good of the those served within their respective boundaries as the same currently exist and as the same may be modified by annexation from time to time; and

WHEREAS, the Board of Directors of the Grand County Water Conservancy District hereby finds and determines it to be in the best public interest that an agreement be entered into among the Districts, and that a separate legal and administrative entity be established, pursuant to the provisions of §11-13-5.5 the Act, in order to accomplish the purpose and maximize the benefits of their joint and cooperative action, including the undertaking and financing of the services to be provided by and the ongoing operation and maintenance of all

water and sewer systems, buildings, facilities, equipment, grounds, and all other resources and assets which are the properties of the Districts;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Grand County Water Conservancy District, Moab, Utah:

Section 1. The Chairman of the Board of Directors is hereby authorized to execute, on behalf of the Grand County Water Conservancy District, that certain Interlocal Agreement Creating the Grand Water and Sewer Service Agency.

Section 2. This Resolution shall take effect immediately upon passage.

Council Member John Groo seconded the motion to adopt the foregoing resolution. The motion and resolution were unanimously adopted on the following recorded vote.
