Presidents' Letter

With an early spring you've got to love it. We're way ahead of schedule for having a great summer. Don't forget to show some sympathy to the snowbirds who weren't here to enjoy the great weather in March and April.

So with spring here and summer around the corner, it's time to think about the summer General Meetings of the BLCA. This year we have what we think are important topics and issues for all lake residents.

We'll start on June 12th with our annual picnic. Sandwiches, chips, beer, wine, and pop will be served after the general meeting. The Sheriff will be on hand to discuss rules and regulations for safe enjoyment of the lakes. This meeting and all the others will be at the <u>Palmer Township Hall</u>. June's general meeting will start at 10:00. We strongly encourage you to bring the kids for this one.

July 10th the BLCA Board is trying something different. We will be starting the general meeting at 9:00 AM instead of 10:00. To accommodate the earlier start, the Board will meet in the evening during the week prior to the General Meeting. For the July General Meeting, the Board decided to concentrate exclusively on *Septic System Concerns*. Representatives from a fly-over photography company will be present to discuss infra-red photography technology for detecting septic system failure, as well as options for the BLCA. As we continue to learn, septic system failure is another part of the equation contributing to poor water quality. Addressing our water quality issues will most certainly include septic system compliance.

August 14th gets us to the topic of *Algae*. We're sure all of you remember last summer's algae outbreak. Our plan is to bring you an expert who will explain the causes of algae outbreaks and possible solutions to prevent them. August is also our annual meeting when BLCA members vote on the 2011 budget and elect new board members. This is an important meeting that determines the direction of the Association for the coming year.

As your elected board members, one of our goals is to provide you with information to help you enjoy your activities and life on the lake and to improve and keep our lakes healthy for future generations. Best Management Practices

First a rant: Why is it every year ice a few select ice fishermen feel compelled to leave their garbage all over the ice? Just prior to ice out, I picked up 7 glass bottles, several tin cans and plastic bottles. All of this within 150 feet of where the kids swim and the dock is placed. It's no wonder we typically make at least one trip to the ER each summer for stitches. I'd certainly like to hear any suggestions from association members on how in the future we could curtail this ignorant behavior by our winter guests.

Once again, this year's spring melt - off caused high water conditions to our chain of lakes. Another reminder to everyone the importance of keeping our shorelines clear from debris such as campfire remnants, pet droppings, boards, lawn furniture and beach toys at all times. The water came up fast. Most likely any debris left on shore ended up in the lake, potentially adding to our already high phosphorus levels. Our lakes have a long history of this type of water level fluctuations, especially in the spring, and after significant rainfalls. Please take necessary precautions to decrease the impact that high water can have on our water quality.

With early ice out and favorable temperatures most of the lakes residents are getting a jump on the summer season. Boats and docks have made an early entry into the lakes this year. It's sort of like getting an extra month added to the summer. Why not utilize that time gained to plan a lakeshore restoration project, rain garden or buffer zone? How about volunteering for one of the many projects the BLCA has on the docket in the coming months. There are so many ways everyone can get involved in the Association. Even if it's for a couple of hours on a specific task, the BLCA could really use your help. Please make a point to attend a BLCA meeting this season. They're held on the second Saturday of each month. Be informed and get involved. (I also heard a rumor they're serving free ice cream⁽²⁾)

Shoreland Restoration Workshop Report

On Saturday, April 24, the BLCA sponsored a Shoreland Restoration Workshop at the Palmer Township Hall, moderated by Co-President **Kenzie Phelps**. The featured presenter was **Mark Basiletti** from Sherburne Soil and Water Conservation District. Thank you, Mark, for once again taking time to share your knowledge and ideas with us. Also, thanks to **Barb and Darrell Tucker** for arranging and preparing a continental breakfast.

The purpose of the workshop was to provide interested property owners around the lakes with information about conservation projects such as shoreland restorations, rain gardens, and other run-off controls to help reduce pollution of our lakes.

Mark provided background information about the watershed for the Briggs Lake Chain and Big Elk Lake and discussed the major contributors to pollution factors likely responsible for growth of algae in the lakes. The watersheds are different for the upper lakes and for Elk, but both are large for the size of our lakes. An earlier two-year study of sources of phosphorus (a large factor in algae growth) showed that the upper lakes receive much of the phosphorus from the Bayou and from Briggs Creek. Big Elk's phosphorus sources are mainly from the Elk River and from Lilly Creek. Run-off from roads and lawns is also a contributing factor, and one that individual conservation projects can help reduce. Other research suggests that a 10% reduction in phosphorus levels could have a noticeable effect in algae growth. Mark also described the various ways property owners can reduce and filter run-off and showed examples of projects that have been done around the Briggs Lake Chain.

Kenzie and **Chuck Heinemann** explained opportunities for grant funding for conservation projects through the Shoreland Education and Restoration Project (SERP) and Healthy Lakes Mini-Grants (HLMG) and described the process property owners can follow to apply for funding. SERP grants are funded through the Shoreland Habitat program of the Minnesota DNR and can reimburse property owners for up to \$2,500 for a shoreland restoration project. HLMGs are funded through a \$5,000 allocation from the BLCA Water Quality fund and can reimburse up to \$500 per project (which may include any that would reduce run-off into the lakes—such as shoreland restorations, rain gardens, and run-off diversions).

We encourage those present (and other property owners) to use SERP and HLMG funding to help pay for a conservation project and help reduce run-off into our lakes. These projects will have a long-term benefit in improving the water quality of our lakes.

BLCA volunteers will help with planning, grant application, and actual labor for planting. Contact **Kenzie Phelps**, **Walt Munsterman**, or **Chuck Heinemann** for more information.
