JASON ROBERTSON WITH FLUID EQUIPMENT TO ANSWER QUESTIONS FOR BOARD ON TITUS TWISTER

Discussion

Petty - We invited you here to talk about the Titus Twister. We did approve that quote at our last meeting are excited to get it in and get it installed. There were some follow up questions we had though, and I know that you've kind of prepared some things.

Jason Robertson - Well, I hope if not I can get quick answers from those guys. So yeah, so Jason Roberts, I met some of you out at CC station I believe a few months ago. I'm with Fluid

Equipment. I'm the President of Fluid Equipment. Unfortunately, for Kennie, when I promoted, I kept 5 accounts. Fair Grove was one of those five, so he still gets to deal with me as a sales rep for it. Fluid Equipment is a water wastewater provider, we've had engineers on staff or based out of Kansas City. I have a full service crew, a repair shop four boom trucks here out in the territory, we service the Western from Missouri and all of Kansas. We also have a facility in Wichita as well. So that's kind of a very high level overview of what Fluid Equipment is. For the Titus Twister, my understanding was you were curious about operating hours and what kind of the cost of ownership was going to be for that? I'm going off the number that I got this morning on what kilowatt hours, which seems high for Missouri, but it might be accurate. Is the a charge of about 29 and a half cents per kWh in this area?

Hodges - That's not right.

Robertson – That seems high.

Hodges – It's like .08, something like that. 5 or 8, isn't it?

McMains – I have no idea.

Hodges - Yeah. How much?

Boncuk – It depends who it's through.

Hodges - Well you've got Southwest and you've got...

Hokanson – Cause that's what Sara told me it was.

Davis – I literally got it off of our bill this morning.

Hodges – Well it might be a little higher than that. 10 or 11.

Petty – Is this site on Southwest or Liberty?

Hokanson – Liberty.

Petty – Okay. So that's probably it.

McMains – So that's probably a little low actually.

Boncuk – There's the answer.

Robertson - So here's what I'll say to that. If you find out what the wattage charge is per hour, take that number of times 57 or 66 per day. So the way I figured that we would run that it's based off amps drawn wattage drawn on that 6.2 horsepower blower. That amp draws going to vary depending on the level of the water level right. So the diffuser I don't. Everybody else on the Council. But the no one looks like it sits down. In the bottom of the well. Blows diffused there. So is that water level rises, there's more pressure that's to be built within that? So in a worst case scenario at 29 and a half cents per kWh. It's going to take about 57 to 66 kilowatt hours a day and that 5 amp range, right? So that's kind of what I would say is a worst case. That's if we've got high level in that thing all the time. That equates to about \$512 to \$590.00 a month. But if you

find what that number is that you are getting charged per hour, take it times 57 or 66 and that's your per day usage. We can really narrow that down. Missouri Rural Water does conservation audits for things, but without having that AMP draw to know what that thing is actually pushing, I went with five cause that's on the high end of what it would be I anticipated would be less than that?

Hodges – Alright. One of my questions was to you, I was down that day and we discussed it. Uh, how long would it run? You was talking about down that day we could have it on a timer or something or what should it run?

Robertson - I wouldn't recommend a timer if so, since that demo which it's it's done a good job and so over the pumps, that's a pretty clean wet well right now. So the last four years there was a lot of alarms that happened to that station. There's about a six inch grease mat that the transducer would write up which tells the pumps shut off and on burning bumps up was costing a lot, right? We did not represent this company 3 years ago. We just signed them up about a year and a half ago. So the Titus Wastewater Solutions is who is the science behind the technology? So that was was part of the issue is they don't want to do a timer in them just because it it kind of over complicates what is the simple control panel? What I would recommend doing is having Kennie just keep an eye on it. Because we recommend running it 24/7, right. 90% of the town flow goes through that lift station. And there's a lot of H2S gas. There's a lot of nasty stuff coming into that lift station as we have witnessed. I would recommend renting it 24/7. If you get into a low water time like right now, you can probably go back and shut it off for a week or so, right? Just keep an eye on it because it will catch up pretty quick. Same with the ozone, right? So we recommended ozone on this, which will knock out the H2S and nasty gases which as you disseminate that biological mat that's sitting in the bottom of that wet well, it creates the H2S gas pushes it down the forced main. You'll have corrosion and pipes. You'll have corrosion in your concrete and your manholes all the way back through the plant. Those that ozone generation that can happen there is what's going to knock that H2S down. We are making a modification of the panel because when we ran the demo unit or a lot of ozone. I don't think you need that much, so we've got two of the smaller crees is what they call them, it's the lights for the ozone generation. The maintenance on those is about 15 minutes a month going out and just clean them. They'll provide a brush that you open them up and just clean the bulbs up with. Again, that's going to be subject to seeing what the build up looks like on them as the thing runs. Roughly 15 minutes once a month.

McMains – Is that something you do or is that something that Kennie does?

Robertson - So that's something that we would include as part of our maintenance plan. I'm through Fair Grove enough that I'd have no problem doing that for 15 minutes a month. I want to keep an eye on it as well.

McMains - What's the life expectancy of one of these Titus Twisters?

Robertson - Of the whole unit. So there's several pieces and not a lot of moving pieces, the blowers are the the main item? You'll get 5 plus years out of the blower life on a 6.2 horsepower blower, which this has on it. A new one right now is just north of \$5000 if one were to go bad. They have a year warranty on them.

Robertson – One year.

Hodges – We was told six months.

Robertson – No. It's a one year warranty.

Hodges – It's changed then.

Stewart – It's longer. Perfect!

McMains – For the better.

Petty – Good. It's longer.

Hodges – Yeah, no. I was concerned about the six months. I said, I said man, that ain't got no faith in their machine. You know, for just six months.

Robertson – No, it's a one year warranty on all the items that are there. From the unit itself, so the ozone everything on it is stainless steel it will be stainless steel hard pipe from the unit into the wet well down to the head of the unit. That's purely because if you have any type of hose it's not going to hold up that ozone, it's going to have cracks and holes in it. So it's stainless steel pipe all the way through there. The crees so they redesign their crees 3 years ago. They've not had any burn up yet of the 160 they've installed the United States. So the Crees I wrote down \$830 and those have to be done. You guys will not need to run, so you're gonna have two crees, which are the bulbs. Those need to run 1, so it's the one is secondary as a backup in case this one were to screw up. So you've got a redundant system. I would anticipate the crees will last a decade in this application.

Hodges – The machine you brought down there and demonstrated to us, is that the one we bought? You was talking about not needing a machine that big. Did we get a smaller one?

Robertson – You got a smaller ozone dosage.

Hodges – Okay. But the pump and everythings the same?

Robertson -- The horsepower and the blower are the same.

Hodges – Is it smaller then what you had down there?

Robertson – And the head unit is the same size and that will also come, the price that you guys have includes the concrete to mount it to.

Petty – Is the ozone something that is, you said the crees and the bulb creates the ozone?

Robertson – Correct.

Petty – So it's not something that we have to replace as a monthly...

Robertson – No you don't buy the ozone. So the ozone can't be transported. It has to be generated on site anywhere. It's taking oxygen from the outside air, putting it through an

electrical process that creates the molecule and breaks it down. I could really bore some people if you want to get into that. So that's how that works.

Petty – Okay.

Robertson – This will have an air conditioner unit on it so we're talking wear items. It's very similar to what an air conditioner on your house would look like, right. If we shut the ozone off for a time period, you do not need to run the air conditioner with it. The air conditioner units, they've seen, and I asked Titus on how long they've been getting out of those and they are saying four or five years but at that four to five year mark, they're not replacing the air conditioner, they're replacing the blower fan. It's like a \$130 element in it, similar to what happens with our residential air conditioners. Those are really the wear items on it. Everything else is hard plastic diffuser heads that will last 20+ years even if they're running nonstop.

Petty – And this is, the whole unit itself, is included in our semi-annual maintenance...

Robertson – We will do the maintenance to it. And we can do amp draws and see how everything is working. So we'll add a page to what the maintenance document that Kennie gets back that kind of shows a breakdown of what's happening to each pump station. We'll include that through the years so we can make sure that the amp draw, the motor and the blowers are working fine. As we get more of these installed, we're going to have probably 10 in Western Missouri by the end of this year, I will anticipate that we will be stocking blowers as well at our shop and facility in Kansas City so that way if something were to be down quick, we could get it replaced in no time. And with your all's maintenance contract, you've got a 24 hour response time guarantee so if something were really to go bad, we could be down here pretty quickly and replace it.

Petty – Is the warranty all handled through you if for some reason we had a faulty part, you would...

Robertson - Yeah, I would handle all of that. I will handle all communication with Titus.

Petty – And then, installation.

Robertson – That's also included in the price we have.

Petty – When is it gonna happen?

Robertson – When?

Petty – Yeah.

Robertson – I don't have it ordered yet. I haven't gotten the purchase order sent to me.

Hokanson – I didn't tell him to do it because we had questions.

Robertson – So once, if this is a green light, it'll be 3 to 4 weeks likely delivered and that's about how far we're booked out on field service stuff right now so call it a month, month and a half. It wouldn't be a problem.

Petty – Is that including the concrete?

Chief Riggin – I said I wasn't going to talk long but four score and seven, nah I'm just kidding. There's a lot that I could say but I would like to do something more formal as we move forward. It just seems like there's thousands of little cool things happening all the time. The one thing I did want to highlight is I'm almost to my 5-month mark and my goal was to get us to a place where we could get grants. We're working off a grant right now doing a DWI enforcement. So it's a MoDot mini-grant and it's only \$1,250 but it's putting Brian and Billie out doing DWI enforcement and I think with the big huge push that happened last weekend, there was only 5 or 6 police departments with the Sheriff's department that actually pushed out to join a concerted effort and we got a shout out from Jim Arnott for that. So I thought that was pretty neat. So Billie and Brian both went and worked on this thing here for us. I am probably about 60% through our policy. It's going faster than I had hoped so that's really important. I put something on your desk, speaking of policy, that's really important, policy along with working with the schools has conversed into one idea. So, the schools are recognizing that we do have staffing issues and that they would like to have police presence at sporting events. Dr. Overstreet and I talked a little bit about that today and the reality was that for what they would like to have and what we could provide on duty just won't match. It was recommended that maybe we have our officers at a capacity where they could work off duty or what we call extra duty in Springfield and I like that term so I'm going to be using that term and he agreed. So he would like to hire our officers in a contract way. We're not paying for it, so on and so forth. But what's in front of you is basically what I feel like needs to happen. Most schools do not do this in the state of Missouri. I had that

opportunity to travel all over the state of Missouri in my former job and this is a protection for the officer, the city and sets out clear cut expectations of the school. I'll give you a quick example. If a HVAC contractor, large contractor, has several employees that want to work, do some moonlight, that HVAC guy that has all of those certifications through his other company can use those on his own as a 1099 employee. Basically he just contracts and comes to your house and fixes your HVAC. Police do the same thing. We have allowed them to have a commission but what we want to do and what we realize is beneficial for the city is to let them go earn money as a contractor with other businesses in the community. That gives police presence where they would not normally have police presence and that's basically what this is saying. It's saying hey, the school would like to hire, or any business in Fair Grove, would like to hire our officers off duty and to give police presence. But if you read that very carefully it sets the terms very clearly. It states that they then become the employer for work comp for all the things that could happen to them. If he's, Brian, I use Brian as an example cause they asked him to come this Friday night, if he's walking up and down the rows of seats, slips and falls and breaks his leg, who pays for that. Well this contract would say that the school is responsible for 100%. If Brian loses himself and breaks somebody's arm there working for the school and there's a lawsuit they then become the primary payout for that lawsuit and then if we in turn get sued because of his school employment, they have to reimburse us for that. Basically what it's saying is anyone who wants to hire our officers in an off duty capacity has to take the full brunt of everything financially. I explained that to Dr. Overstreet today and sent him a copy of this for his review as well but I think this is the way to go and it's not the way a lot of schools go and I've seen case law out of Kansas City as well on this type of thing where an officer was killed and his widow had to sue everybody to get any payment and then the judge was mad and then everybody had to pay. In this case, had there been an MOU the judge would have been able to say well that's easy, your paying, not them. Because the City of Kansas City also got sued.

Petty – I love it. Because it deals with all kinds of legal stuff, I would like to have this sent to our attorney for review.

Riggin – You should.

Petty – You mentioned that they want to hire him Friday.

Riggin – Right. So having said that and we talked very briefly about this today, I told Dr. O that we may have to pump the brakes on this and they may not have any coverage unless this can get done before Friday at 5:30.

Petty – So we can send it to the attorney, have them review it. She's pretty timely so far, if we get it back in time we could potentially have a special meeting to sign this upon her recommendation if that is what she recommends. I don't know if she's gonna want to redline it, send it back and forth. I would assume the schools attorney would want to take a look as well.

Riggin – Possibly.

Petty – That's what I think our next move should be. Obviously open for discussion.

Stewart – So the Police Committee kind of talked about it and that's where we're at too. Just get a consensus of the Board to send this to the attorney and let the attorney review it.

Riggin – I don't want to be in a hurry and Mark and I talked about that. What I don't want to have happen is to have this scenario where we're just trying to shoehorn things in just so they can have coverage Friday night. Cause the truth is I'll have one officer on Friday and I know she's already over her head with all of the arrests she's made. And I explained that. I said we need reports done, we need her to patrol when she can and she'll come by when she can. He gets that. But having said that, I also don't want that to be the precipitating factor to make a mistake. The attorney should look at this. And just so you're aware, literally, this is Springfield's MOU. I only changed like four words. That was it.

Stewart - And it works well for us.

Petty – Thank you.

McMains – I'm going to go out on a limb and say this will not get approved by Friday.

Riggin – It's fine. Dr. O understood that...

McMains - Maybe have their SRO go out there. I know he's coaching now too but.

Riggin – Yeah, that's not gonna happen. We already talked about that. They do not have police coverage and they understand that and we'll work with it. It is what it is. We're moving toward that place a little bit where we're trying to bring things into 2025. This is one of those things where police departments and schools are making mistakes all over the state of Missouri, all over the country and we don't want to go there. We want to actually be a trendsetter and say hey, we actually try to do things correctly. But with that is the policy we created, I didn't make a copy for every one of you but if you want to pass this around, you can have this one because I don't like to make copies. But basically this is my policy so think in terms again of Springfield, Kansas City PD and Missouri School Board Association Center for Education Safety all fed in to these 3 or 4 pages. Basically it's in Lexipol as well right now. So this policy references that MOU as a requirement for anybody in Fair Grove wanting off duty officers. But I won't finalize this until you guys are like, yeah, this is where we wanna go and the attorney finalizes what her thoughts are on that. Then I'll finalize this policy and I can send it to you in PDF.

Petty – Okay. Then looking for consensus of the Board to send this to our attorney for review.

Stewart - Send it.

Cooke – 100%.

Short – I concur with you Mark.

Petty – Unless there is a state statute or an ordinance that says you have to bring certain things to the council, I think, if it involves the employment of the officers and/or the liability of the city and responsibility, I think it would be good to bring it to us. Overall though, any policy changes that you make, I would say if it's anything within the realm or the scope of the police, policing, police department falls to you. Steve is right. The Mayor does have the authority to recommend changes and/or the direction. However that can also be overridden by this Board. It's a balance I think. For me, in this position right now as Mayor Pro Tem in a temporary setting, I fully support the police department and the Police Chief defining the policies as appropriate for the City of Fair Grove under Missouri State Statutes.

Riggin – What's nice is, and this is important to me as well, moving forward, if you keep Lexipol in years to come, it self updates. So really what you have is, I'm not making this stuff up, I'm looking at Lexipol, Federal, State, Local. Literally Senate Bill 68 just got passed and some of that will effect police. That will come out and that will pop up as an update, some of those pieces. So you know moving forward as Aldermen, whoever occupies that office, as long as you keep Lexipol, you at least have some semblance of this is not just made up stuff.

Stewart – And once it sends to you, you send it out to the officers to sign and say they read it?

Riggin – It does it within the policy. So basically I can go in and get a report and I can see on the excel worksheet who has looked at what policy, when it was sent out, when they finalized it saying yep, I read that. And I can do that every year and I can resend out new ones. Eventually, I turned this function off, they'll get tests called briefing test. Like what we used to have to do at SPD, they will get that so it will quiz them over policy. I turned that function off right now because I'm asking so much of them. They're reading policies, doing trainings, it's a lot.
