Chinese Hardwood Chip Imports Expected To Double

BRUSSELS, Belgium— Chinese hardwood chip imports will double from 6.3 million bone dry metric tons (BDMT) in 2011 to 12.7 million BDMT in 2016, according to the International Pulpwood Trade Review forecast.

China's imports of hardwood chips have increased six-fold over the last four years (2008 to 2011) from 1 million to 6.2 million BDMT. This surge in volume was the result of large new pulp mills being built in China near port facilities. The expected construction of a series of new pulp mills over the next several years will drive China's demand for hardwood chips even higher. While China's demand grows, Japan's projected decrease in domestic production of bleached hardwood kraft pulp will continue to diminish its demand for imported hardwood chips.

NY Bill Strikes Language Preferential Toward Plastic Ties

ALBANY, N.Y.—On May 29, New York State Assembly Bill A5580 was amended to delete language considered preferential to plastic composite railroad crossties.

For the purpose of providing background, on Feb. 23, 2011, New York State Assembly Bill 5580 was introduced, giving preference to the purchase and use of plastic composite railroad ties over treated wood ties for certain subway and railroad track systems.

In early 2011 (preceded by similar work in 2010), a coordinated effort was made by the Treated Wood Council, the Railway Tie Association,
