2017 Breeding Contract for Gypsy Stallion Icor

1. PARTIES

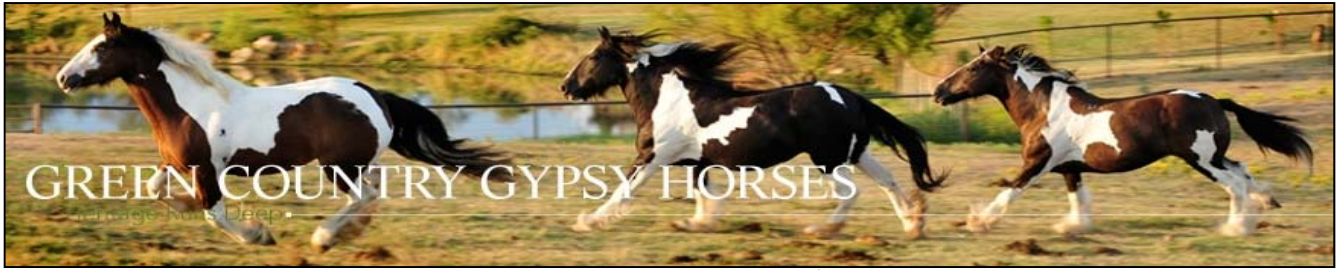

2. BREEDING SERVICE FEE

- 2.1. The breeding service fee for Green Country Icor ("Stallion"), shall be \$1,500.00 United States Dollars (USD, "Fee"). This fee includes a \$500.00 non-refundable booking fee upon signing this contract. This entitles mare owner to breed one mare to the stallion for the 2017/2018 breeding season by artificial insemination, by chilled shipped semen. The balance of the fee is due to GCGH at the time of the collection.
- 2.2. Before collection, the owner must have credit card information available to veterinarian of the stallion owner's choice. At this time, veterinary and shipping fees will be charged and paid directly to the vet.

3. TERMS

- 3.1. GCGH will make a reasonable attempt to accommodate Buyer's request for collection date. However, Stallion will only be collected upon days available by GCGH and GCGH's veterinarian. GCGH and GCGH's veterinary service require a minimum 24 hour notice.
- 3.2. In the event of the death of the stallion, or if he becomes unable to stand as a breeding stallion, as determined by a licensed veterinarian, a refund will be made.
- 3.3. Any mare under this contract must be healthy and in sound breeding condition and free from infection and disease. The mare must also have a clean uterine culture.
- 3.4. In the event the service is refused or the mare does not get in foal, the Buyer has return privileges and may substitute another mare for a period of 12 months from the original breeding date. GCGH stallions have a Limited Live Foal Guarantee. "Live Foal", meaning a foal that stands and nurses. If the mare gets in foal and loses the foal before or during birth, the Buyer shall be permitted to rebreed the mare or substitute another mare for a period of 12 months from the original breeding date. Under these conditions, no additional breeding service fee will be required, but all veterinary and shipping fees still apply and will be paid directly to the vet.
- 3.5. GCGH must be notified of mares pregnancy status within 90 days of the mares last breeding date. If this condition is not met, Limited Live Foal Guarantee is null and void.

3.6. Buyer is bound by normal rules, regulations, and policies of GCGH and must sign a contract and follow all instructions included in the semen shipment. Buyer is liable for all legal and collection fees. Foal registration papers will not be signed until Buyer has paid all outstanding bills generated at GCGH.

4. GOVERNING LAW AND VENUE

This Agreement shall be governed by the laws of the State of Oklahoma. Any legal action commenced to enforce or interpret this Agreement shall be brought in state or federal courts with the appropriate jurisdiction, located in Tulsa County, Oklahoma. The parties hereto consent to both venue and jurisdiction.

5. ENTIRE AGREEMENT

All preliminary and contemporaneous agreements and understandings are merged and incorporated into this Agreement which contains the entire agreement between the parties. This Agreement may not be modified or amended in any manner except by an instrument in writing executed by the parties.

6. COUNTERPARTS

The Agreement may be executed in any number of counterparts, each of which shall be deemed an original. All of which together shall be deemed as one and the same instrument.

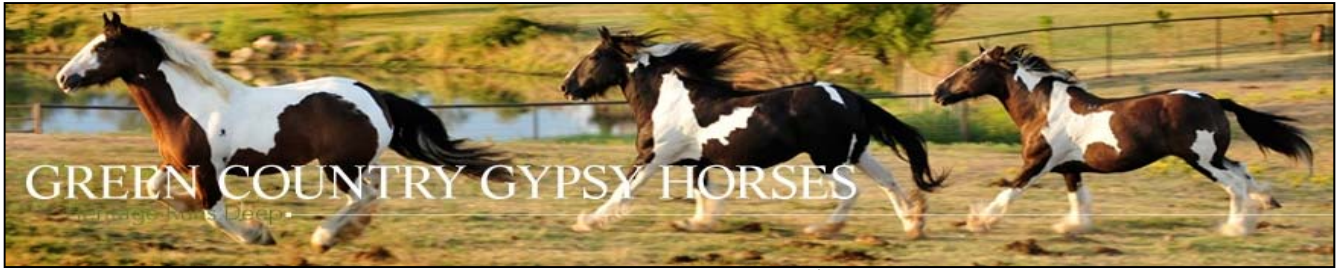
