<p align="center">Birds</p> <p>Quail, Chukars, Pheasant, and/or Pigeons will be released for all test levels. Ducks may be used in the Water Test.</p>	<p>Test(s) Registering :</p>
<p align="center">Handlers</p> <p>Handlers are expected to fire a blank pistol at the appropriate time during the testing of their dog. Pistols used must be incapable of firing live rounds. The GSPCI is not responsible for providing blank pistols.</p>	<p align="center">AGREEMENT</p> <p>I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause, which the club shall deem sufficient.
