Your signature on this Application for Enrollment Agreement indicates your understanding and acceptance of all terms listed hereafter.

- All required forms, including Emergency Cards, the Application for Enrollment Agreement, health records, etc., MUST be completed
 prior to your child attending School Time. This is covered on the Required Forms Checklist.
- The parents/guardians whose names appear on the front of this Application for Enrollment Agreement hereby agree to permit School Time to administer first aid and/or obtain medical treatment for the child whose name appears on the front of this Application for Enrollment Agreement in the event of any injury to the child. The parents/guardians whose names appear on the front of this Application for Enrollment Agreement hereby agree to pay all expenses incurred for such first aid and/or medical treatment and to indemnify School Time and hold School Time harmless against any liability arising from or related to such first aid and/or medical treatment.
- School Time may terminate this Application for Enrollment Agreement at any time. School Time reserves the right to terminate the
 enrollment of any child who is unable to adjust to the center's program or for any other reason.
- School Time does not and shall not discriminate on the basis of race, color, national origin, cultural heritage, sex or marital status.
- The parents/guardians listed on the front of this Application for Enrollment Agreement acknowledge and understand that School Time MUST receive proper authorization in writing to release a child to individuals NOT listed on this Application for Enrollment Agreement.
- School Time will be open whenever possible. However, all tuition payments will be due should the center close due to severe weather conditions or other reasons beyond School Time's control.
- Current <u>tuition installment</u> for your child is due by the 20th day of the month prior, in advance. Additional tuition payments will be due for any days your child attends the center in addition to those days normally scheduled, payable on or before the additional day(s) attended.
- A late fee of \$25.00 per week will be added each month if your child's tuition is not paid by the close of business on the tuition due date.
 Weekly late fees will be processed at the close of business on Wednesdays.
- A past-time fee of \$1.00 will be added to your child's tuition charges for each minute after the center closes that your child is NOT picked up. In the event your child is not picked up within one hour of closing, School Time reserves the right to involve the proper authorities.
- A service charge of \$35.00 will be added to tuition charges for each returned check. Should monthly tuition payments and other fees
 listed in this Application for Enrollment Agreement NOT be paid as agreed upon herein, child care services may be terminated.
- School Time requires written notice two weeks prior to your child's last day of attendance. Failure to provide the required advanced written noticed will result in additional tuition billing. If, after termination of your child's enrollment at School Time, you re-enroll your child less than thirty days later, tuition will be billed as if child care services had been provided on a continuous basis during the enrollment absence.
- The parents/guardians listed on the front of this Application for Enrollment Agreement acknowledge and agree that they shall be liable
 for any and all costs incurred by School Time arising from or relating to the collection of tuition, late fees and/or service charges which
 are not paid as specified in this Application for Enrollment Agreement, including any and all attorney's fees and court costs. They may
 also be liable for interest, charged at the legal rate, for all outstanding balances.
- School Time reserves the right to alter the details, tuition rate, and/or availability of any and all programs they offer at any time
 before, during, or after the school year. Such changes may be effective immediately and will be communicated to families as
 necessary. Such changes shall not affect the other terms contained in this Agreement. All other terms shall remain in full force
 and effect.
- All parents/guardians agree that should their child(ren) be the subject of an executed, court approved custody, separation, or other form
 of legally enforceable agreement determining the custodial status of such child(ren), they shall provide copies of all such agreements to
 School Time and shall provide to School Time any and all changes, amendments and updates to such agreements in a timely manner.
- A complete change of clothes must be available at School Time for each child in the event a change is needed.
- No one may alter or modify this Agreement. All policy changes shall be made in writing. All future written modification to this
 Agreement shall be made with two weeks notice and become material, binding parts of this Agreement. The parents/guardians agree to
 abide by all written policy modifications or alterations made in the future by School Time.
