

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE TOWN OF CLOVERDALE, INDIANA

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF CLOVERDALE, INDIANA:

SECTION 1. That the following described territory, contiguous to the Town of Cloverdale and within the County of Putnam Co, and the same hereby is, annexed to and made a part of the Town of Cloverdale, Indiana, to-wit:

A part of the Southwest fractional quarter of Section 6, Township 12 North, Range 3 West, of the Second Principal Meridian, in Putnam County, State of Indiana, more particularly described as follows, to-wit:

Beginning 1316.7 feet North of the Southwest corner of the Southwest fractional quarter of Section 6, Township 12 North, Range 3 West; thence East 187 feet, thence South 590.75 feet, thence West 187 feet, thence North 390.75 feet to the point of beginning containing 1.4 acres more or less.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and publication according to law.
