 - Engine 4 drain is leaking.
 - Will rotate trucks out for service.
- **Info:** Emergency Vehicle Driver Training is set for October 18th and 19th in Fryburg. Deputy Chief Harrington is coordinating training from our department. Eric Field is one of the instructors.
- **Info:** In February we ordered nozzles and adapters. The expectation is that they should be arriving soon. We need to get together for a workday to install on the trucks.

New Business

- **Info:** During Fire Safety month we will be bringing material and truck to Ossipee Valley Christian School and Pumpkin Patch.
- **Info:** Two existing standpipes are leaking. Cressey's Pond stand pipe at Cram Road and route 117 need total replacement. Need to order parts for head of standpipes. Recommendation to move to male thread on head of stand pipe in order to get a good seal.
- **Info:** Request from town to help with parking for Halloween event.
- **Info:** Maine Mutual has sent a letter in June requiring
 - Structural engineer inspection of station 2.
 - Paint trim work on West Baldwin
 - Certification of compressors over 35 gallons.
