## SB827- ACTION NEEDED!

This is a Sacramento senate bill introduced by Senator Wiener. In a nutshell it takes away local authority control on housing within a 1/2 mile radius of a major transit stop (e.g. Caltrian) or a 1/4 mile radius of a stop on a highquality transit (Bus stop). This would override density controls and height limitations. Thus, you could see high rises going up all along the train corridor which affects Fiesta Gardens. This would override local measures like Measure P.

ACTION: Write to state senators Jerry Hill, Scott Weiner, and Assembly Member Kevin Mullin to voice your opinion.

Board Members in attendance were: Rich Neve - Civic, Roland Bardony - Parks, Mike Russell - Pool Maintenance, Steve Muller – Vice President and Carmen Quaresma - Social Director. Steve Stanovcak -Pool Operations and Joseph D'Agostino - President were absent.

**December 2017 Minutes**: On a motion duly made and seconded and approved by all board members present, the minutes of the December 13, 2017 meeting were approved.

#### Financial - Christina Forrest - not present. No Report.

• Mike Russell – Pool Maintenance made a motion to approve FGHA 2018 Budget. The motion was seconded and approved unanimously by all board members present.

President - Joe D'Agostino - not present. No Report.

Guest Speaker: Lieutenant Matt Lethin with the City of San Mateo Police Department. Lieutenant Lethin answered questions that FGHA owners in attendance had about ongoing traffic issues in the neighborhood and surrounding neighborhoods.

#### Open Forum:

• A homeowner was concerned regarding traffic coming off the freeway to cut through FGHA neighborhood causing traffic issues for residents. He would like to see more police presence.

• A homeowner suggested that signs be posted informing residents dates that street sweeper is in neighborhood so that they can move their vehicles.

• A homeowner wants to know how to inform the SM Police Dept. regarding cars parked in red zones, abandoned vehicles and oversized vehicles. Lieutenant Lethin told them to contact the non-emergency number to report. Officer informed owners that there is a 72-hour enforcement that begins once the vehicle has been tagged.

#### Vice President - Steve Muller:

• Steve Muller reported that Joe D'Agostino has resigned as President. There is an opening on the board that will be posted in the next BEE.

• Gave updates regarding the Sewage Tank – City of San Mateo has not broken ground yet.
