STORMWATER MANAGEMENT DURING CONSTRUCTION



There is a lot of construction jobs during the summer months and we want to share some information from the Environmental Protection Agency. When stormwater flows through a construction site, it can pick up sediment, oil and chemicals and carry them downstream to local water bodies. Here are some tips to prevent pollution of these water bodies:

- △ Construction entrances should have a pad that keeps mud off the street
- △ A fence or barrier should be installed that keeps soil and construction debris from washing downstream from the site when it rains, especially sites on a slope or those with dirt piles
- △ All storm drains near a construction site should have a protective barrier around them to prevent debris and muddy water from entering storm sewer pipes
- △ If you see muddy water, chemicals, dirt, or any water that seems polluted flowing from a construction site, call the Borough Manager or the Public Works Department at 412-241-5080.

POLICE REGIONALIZATION STATEMENT

On May 31, 2023, Swissvale and Braddock Hills met to discuss the possible regionalization of their police departments. Elected officials, police chiefs and borough managers met to discuss the interest of regionalization between the municipalities and discussions they had with their residents.

Both boroughs decided to invite the State to provide a study regarding regionalization. This study would be conducted by Pennsylvania Department of Community and Economic Development (DCED) and would provide a lot of answers and guidance to the process. The elected officials, chiefs and managers agreed that it would be a complicated process and that they, along with their residents and business owners, would have a lot of questions. So, to be able to answer these questions and anticipate any issues that may arise, it would be best to invite DCED to start the process.

Please note that this is only a study and neither borough is committed at this time. This study will allow the boroughs to make decisions that is in the best interest for everyone affected by the regionalization of both police departments. The mayors, council members, police departments and administration of Swissvale and Braddock Hills ask that the residents and business owners be patient during this time and that the elected officials will keep everyone updated on developments as they happen. Again, this study is to answer questions and ensure that it is in the best interest for both municipalities at this time.
