This year a lot more units in Arizona participated in Wreaths Across America giving their cemetery a beautiful remembrance. ### **BOOK OF REPORTS**

### CHAPLAIN 2024-2025

At the end of the 2025 year, the Department of Arizona had 40 out of 85 Units actively working the Chaplain Program. Two Districts sent in reports. Two Unit's reports did not meet the criteria by Department of Arizona Guidelines for reporting for awards. Out of the 40 reports, only three included some type of narrative that was eligible for a Department award. Those three were then judged by three persons not affiliated with the American Legion Family. None were sent after the May 1 deadline.

The Chaplain educated members and fellow chaplains by sharing information in the Department Monthly Bulletins, and the BandApp. Information was also shared on social media.

Of the Units reporting, there were 202 "Sympathy" cards sent to members and families. There were 221 "Get Well" cards sent to members. There were 467 "Thinking of You" cards sent to members. There were 782 "Joy" and birthday cards sent to members; and 195 check welfare phone calls made to members. Several Units and Posts also have members that regularly visit nursing homes and hospitals, including the VA clinics, hospitals, and homes throughout the state.

Unit and District Chaplains conducted 669 Invocations at Unit and District meetings, special events and holiday functions. They conducted 543 benedictions. Units and Districts also conducted 84 charter draping ceremonies and presided over 58 memorial services. They promoted and supported "Gold Star" families by paying their dues, sending cards and monetary and non-monetary gifts. These donations totaled \$361.00. Donations from members for "Gold Star" families and memorial donations totaled \$5194.00. Some held luncheons in their honor.

There were 576 members that attended 98 funerals for members and members of the remaining entities of the Post Family. There were 147 grave markers placed. This included "Wreaths Across America", where many Units participated in some capacity.

In February, all the Units reporting participated in a Four Chaplains Ceremony in some capacity, either on their own or with the Post Family.

Eleven Unit Chaplains are creating a prayer book for their Unit President. Thirteen are helping with the Department President's Prayer Book, and four are participating in sending in prayers for the National President's Prayer Book.

In August, the Department Chaplain attended the American Chaplain's and Children and Youth Conference in Indianapolis. The Chaplain was the only chaplain from Arizona and the only Auxiliary Chaplain in attendance. The Chaplain gained a wealth of spiritual knowledge, as well as Children and Youth programs, while attending the Girls State meetings with the Arizona Girls State Director, after her meetings concluded for the session.

Upon returning home to Arizona, the Chaplain promoted what she had learned at the conference and continued to support members and their families.

Unfortunately, this Chaplain and the Department lost five Past Department Presidents this year. Those Past Department Presidents were Josephine Herrera, Helen Stout, Jennie Molina, Centennial Tyson-Stewart, and Joyce Arent. Legion Family Memorials were held by the families of two of the Past Department Presidents, in which the Chaplain attended, while the other three held private family memorials. The Department Chaplain sent 30 "Sympathy" cards, 15 "Get Well" cards, and made 28 welfare check phone calls, checking on members and Past Department officers, whom had medical procedures, and deaths in the family. The Chaplain also conducted ten invocations, and seven benedictions throughout the year at various events, dinners, and meetings, including the DEC meeting after Convention and meetings at Fall Conference.

The Department of Arizona Auxiliary Chaplains and members will continue to "Lead the Way" to support veterans, active-duty military, and their families.

The unit and legion family members from Arizona are diligent, reliable, dedicated, and creative, however, they have under reported or have not reported to this Chairman. The numbers and activities that were reported include fundraising for all aspects of the Children and Youth Program. Units donated money, needed items, time, they cooked, hugged, and brought smiles and joy to military and community kids. There were many ways to volunteer some helped high school juniors with Girls State, some collected, counted, packed, and delivered Back to School Supplies. There were holiday fundraisers and holiday parties for the children, Breakfast events for Gold and Blue Star families, Care Closet – for kids that need a little extra help, some adopted needy families for the holidays, some legion families toured group homes, foster care facilities, and then there were those that attended a Readiness event at a local National Guard Base. These are but a few of the activities and events that were planned and executed in our state.

Collectively units contributed \$1,050 to the American Legion Child Well-Being Foundation. The ALCWF was promoted by educating and having open discussions with members at monthly unit meetings and district meetings. We also acknowledged the name change from Welfare to Well-Being.

How members celebrated April - Children & Youth Month:

Most members wore purple shirts on April 15<sup>th</sup> which is Military Kids Day. Units announced in their monthly meetings, posted on social media, created flyers and posters. Some set up tables to bring awareness of April 15<sup>th</sup> Active Military Kids Day with Purple-Up T-Shirts - Kids are Heroes too.

Honored Veterans and Families:

One unit planned a Baby Shower for an expectant mother at Luke Air Force Base. They raised funds, bought gifts, and showered the new mom with love and supplies. Parties were held for

children; Halloween with candy, games, and spooky houses, Christmas with gifts and photos, Easter Baskets and stuffed eggs, and one unit has the popular Polar Express "train" where photos were taken with Santa. A few units adopted families at the holiday to improve their situations with food, gifts, and love. Many units helped their Post and Legionnaires with the Veteran's Day Events. Some units had educational functions at schools where the student council asked a panel of Veterans questions. A demonstration of the 13 Folds was given for students. Some units hold flag retirements and etiquette. One local Brownie Troop assisted with a 9-11 memorial and observed POW/MIA table. On a tragic note, suicide entered the ranks of our military at Luke Air Force Base. Unit 62 reached out to "Be The One" to support the 8-month pregnant widow and her 10-year-old daughter. The family was showered with diapers, various sizes of clothing, and needed items including love gifts for the daughter.

### Giving and donating:

Many Back-to-School Supplies and Backpacks were donated to all ages of students. Care Closet for instant easy to eat food, Pop-up Prom Store for donated evening wear and accessories for men and women, Care Closet for hygiene items for special needs students to be used for their Life Training Skills. Some toured and donated to a Group Home for "aged out" youth and some went to an independent foster home facility Sunshine Acres, where they do not "age out" youth.

### Showing appreciation for our Youth:

One unit has developed a Veteran Rock Painting Project, where younger students paint rocks that they may keep or donate to a veteran. Many units show appreciation for JROTC with scholarships, medals, and certificates.

#### Fund Raising:

Units held events for fund raising such as Octoberfest, Luau, New Year's Eve Dance, Grease Tea Party, 4<sup>th</sup> of July BBQ, and Past President's Parley Dinner for Nurses Scholarships was a Movie Themed night costume dinner.

Finally, the impact and results from the Units combined with their Legion Families raised a combined \$46,815 to go towards the Children and Youth Program, 4,136 kids were educated, challenged, fed, assisted, honored, entertained, clothed, awarded, or touched in some way by volunteers who kindly donated 7,901 precious hours, by many more than the modest 155 reported volunteers. Those who have volunteered anonymously are held in high esteem and are very much appreciated by the officers they have worked with over the course of this year. Service, Not Self is exemplified by many units and legion family members throughout the Department of Arizona.

### CONSTITUTION AND BYLAWS ANNUAL NARRATIVE

### DEPARTMENT OF ARIZONA AUXILLIARY

### DANNY MURPHY, DEPARTMENT CHAIRMAN, CONSTITUTION AND BYLAWS COMMITTEE

I was appointed as the Chairman by Department Madam President, Stacey Mayberry for year 2024-2025. Units and Districts were requested to review and submit their C&Bs initially by me via the Department Orientation, whereupon I explained the purpose and importance of these governing documents.

Department, Districts, and a majority of Units upon my request, have conducted annual reviews of their C&Bs, and if necessary, made the appropriate changes to meet National and Department verbiage and compliance. It was emphasized that a review should be annually conducted to ensure equity and compliance.

Ongoing Mission and Leadership Trainings were conducted throughout the state. They were very helpful, especially to Units in educating and explaining the purpose and importance of C&B components. Areas of finance, membership eligibility, and officer responsibilities were the most asked and covered areas in each training. To ensure continuity among all members, it was encouraged that all members receive the most current copy of their C&B.

Districts and Units were very receptive in reviewing their documents. Three (3) Districts and approximately 40 Units submitted their C&Bs, mostly after making changes and were even more receptive in the advice given by either me or my committee as to the rewording of their changes, and why. We were very clear in telling them why the change was necessary but also where it is stated in both Department and National C&B in the effort to meet compliance. It is necessary to teach and advocate each District and Unit and allowing them to be part of this process as opposed to coming across as controlling or indignant.

Each District and Unit was also educated on the difference between a Bylaw and a Standing Rule, in addition to the approval process of each. Units were encouraged to use Standing Rules, when applicable, as opposed to writing or revising Bylaws.

There should be an increase in education and communication of C&Bs. Each District and Unit should have an appointed Parliamentarian. Ongoing training should be conducted at the Department level specific to Parliamentarians as to the purpose and importance of these vital documents and to ensure their role in communicating and educating their Units on respective changes, writing bylaws and standing rules, the importance of meeting compliance and creating an atmosphere of inclusion and education among members.

Either Madam President or I, were involved in the quarterly ZOOM calls conducted via National regarding Constitution and Bylaws. I found through the Q&A segment of these calls, that the issues coming from Districts and Units are similar across the board with regards to finance and member eligibility.

I am very fortunate as my past two Department Presidents have a strong background and even stronger knowledge in both these areas that they have passed down to Districts and Units via Leadership trainings, conferences or just plain one on one conversations.

Districts and Units must develop and promote continuing and brighter leadership throughout their memberships. Whether it be committee chairmen or officers, we do this by advocating and educating on their governing documents and their purpose and principles. We emphasize our mission and values as well. We do this through encouragement. Constitution and Bylaws are the foundation of building our strong leaders for the future.

Units participated in American Education Week by providing Thank-you notes, lunches, cookies, and treats to teachers at local schools. Thank-you cards were sent to staff members, including school nurses, custodians, and bus drivers. Units held in-person events, a Stuff-the-Bus event, and drive-through events to collect and distribute school supplies and backpacks to children at local schools. Units presented videos and booklets on flag etiquette and Halloween safety, and donated craft supplies. Schools were presented U.S. flags and Arizona state flags to replace old flags in front of schools and in classrooms.

Units participated in the *Give 10 to Education* program by providing school supplies and educational materials to schools. Members of all Post entities donated school supplies or money toward purchase of school supplies. Other necessities such as backpacks, tissue, hand sanitizer, wipes, story books, toiletries, and shoes were collected and distributed to local schools. School wish lists were fulfilled. Thirty-five *Give 10 to Education* certificates were awarded to Unit Members.

All Units reporting also assisted needy students in many ways. Clothes were donated and delivered to a school district clothing bank where every student in need has access to free goods. Donations were also made to Coats for Kids and Kids in Foster Care. Food pantries were stocked. Christmas Angels worked with local schools to provide gifts, toys, and food baskets for needy students. Units also delivered Easter, Christmas, and Thanksgiving food baskets.

During the 2024-2025 school year, Units reported awarding 27 Unit scholarships, totaling \$26,090. Units raised funds for scholarships in several ways including dinners, raffles, contests, and sales. National scholarship applications and information were published in monthly Unit correspondence newsletters and delivered to local high schools through the mail, email, and in person. Units delivered information regarding the Past Presidents Parley nursing scholarship to community colleges and assisted with the Arizona State University's Veterans Program. In 2024-2025, Nine applications for the *Children of Warriors National Presidents' Scholarship* and one application for the *Non-traditional Student Scholarship*. A Department winner was selected and forwarded to the Western Division Education Chairman for each of these scholarships. Each applicant received a letter thanking them for their application and informing them of the outcome. The Department winners for these scholarships were invited to attend the Department Convention and will receive a \$25 cash award as a token of congratulations for their accomplishments.

The Department of Arizona has established the *Wilma Hoyal/Maxine Chilton Memorial Scholarship*. There are three scholarships of \$1000.00 available annually: one to Arizona State University, one to The University of Arizona, and one to Northern Arizona University. This scholarship is renewable provided the student meets the outlined criteria. Recipients must be enrolled as second year or upper-division students in Political Science, Public Programs, or Special Education. Andrew Wei is currently serving

overseas with the United States Marine Corps and has already earned Bachelor's degrees in Journalism and Mass Communication and Political Science. He is now hoping to earn a Masters degree in Public Administration from Arizona State University. A \$1000 scholarship was awarded this year to Andrew Wei.

Units involved the Legionnaires, the Sons of the American Legion, and the Legion Riders in donating time, school supplies, money, and labor to all the Education and Children's programs. They helped work in a school garden, a Run to the Guns event, and a fundraiser for the Future Business Leaders of America. They assisted with Halloween safety programs, Christmas parties, and Easter parties. Legionnaires acted as judges for an essay contest, promoted scholarships, helped with Girl Scout activities, and attended the awards ceremony.

Units reported presenting "Veterans in the Classroom" programs. Veterans visited elementary schools for interviews, spoke at assemblies and in classrooms about the Poppy story, the Tomb of the Unknown Soldier and the difference between Veterans Day and Memorial Day. Schools honored veterans on Veterans Day with flags, songs, and videos. Units presented programs on the accomplishments of our Veterans by honoring veterans on Veterans Day at local schools. A Veteran read books during Story Time. Veterans spoke about what is means to be a Veteran.

All reporting Units used many community resources or activities to assist students, teachers, or support personnel. Units donated to the Shop-with-a- Firefighter program. Monetary donations were made to a local mentoring program, Junior ROTC awards, Girls State, Girls Scouts, Cub Scouts, baseball teams, Special Olympics, and Future Business Leaders of America programs. A Unit worked with the Political Action Committee for Constitutional Education. Unit Members and Legionnaires volunteered at Fort Huachuca and the Purple Up for Military Kids program.

The Department of Arizona offers the JEAN BATLEY PLAQUE for Units with membership of 150 and under and the CHRYSTEEN FRITZINGER PLAQUE for Units with membership of 151 and over. The purpose of these awards is to stimulate interest in good participation in the Education program of the American Legion Auxiliary by giving recognition to the Unit which makes the most use of the available ideas in education, scholarship, and loan possibilities. These plaques will be awarded at our Department Convention in June.

The Department of Arizona recognizes that our young people are our future, and a good education is the key to their success. The members of the Department of Arizona are devoted to contributing to this success.

On June 1, 2025, reporting on the Year End Finance was 70%, a huge improvement in reporting financial status. Pat yourselves on the back, since the prior two years reporting hovered around 49 per cent.

Financial rules are governed by IRS: Gross receipts under \$50,000, file Form 990N (epost card) or Gross receipts over \$50,000 and less than \$200,000, file Form 990EZ.

Arizona Corporation Commission requires yearly reporting by districts and Units. National ALA Headquarters recommends record retention of 7 years for accounts receivable/payable, budgets, internal audits, check registers, and 10 years for bank statements and reconciliations for all Units and Districts.

One Hundred Ninety-Six, young women from one hundred-forty High Schools throughout Arizona were scheduled to attend American Legion Auxiliary Arizona Girls State at the University of Arizona in Tucson from June 1-8, 2025. Forty Units reported some form of Girls State Activity.

Fifty-one Units sponsored one or more delegates to attend the 78<sup>th</sup> session. Eleven High Schools without Unit representation sent delegates. These numbers are **up** from previous years.

You name a way to make money...members of the Auxiliary did it, to generate the funds needed to sponsor each delegate. Because of today's economic conditions and the rise in Girls State fees, many Units needed contributions from other organizations, people and agencies...Legion Posts, Junior Groups, Legion Riders and SAL Squadrons.

Again, major focus was placed on a standard Orientation with everyone receiving the same information through a power point presentation. Orientations were emailed to all delegates who were not attending and downloaded to phones during Orientations.

We are missing a membership opportunity by not asking delegates if they are eligible to become a member of the Auxiliary. Information on the Samsung Scholarship was sent to delegates again this year...to apply you must be a **DIRECT** descendant of a Veteran. Were girls asked?

Two Units submitted an entry for the **Yvonne Granger Plaque**, and it was a hard decision for the judges to make. Girls State publicity was from local newspapers that covered the events as daily doings, from the Girls State website and Ring Your Bell.

Units rewarded contributors with certificates, plaques and thank you cards. Several Units reported returning the money paid by the Delegate if they attended Girls State and reported back to the Unit. Two new or gently used books were requested from each Delegate as a Community Service Project. They will be given to first responders to distribute when needed.

The Girls State Yearbook is a success and we will be taking orders again. We will continue to promote enrollment for Girls State Alumni Association and "Friends of Girls State". This helps with funding of the two scholarships that are awarded each year.

**REMINDERS:** The political workings of the Department should not be a part of Girls State. The Units work within established Girl State guidelines and policy. This makes it fair for all schools and Units. Allotments and schools are changed each year to accommodate enrollments and bed capacity or Unit problems. **ONLY SPONSOR** of Girls State is the American Legion Auxiliary. All **OTHERS** are **CONTRIBUTORS** to the program. We need to work on payment with one check. We will be working on completion of forms, pictures, school signatures and notarized signatures by email.

We still need to work on the March 1st deadline. You don't have to wait until March to get started as packets are sent to school around January 15<sup>th</sup> each year. This year many Units did not contact schools or become involved. Many schools non participation was due to no Unit involvement. Hopefully we can work on this for next year.

We thank each of you for your **dedicated service and assistance** to the Girls State program. We more than appreciated that when asked to help with extra schools or delegates or take on other responsibilities, you were willing to do so for the program. We also appreciated your thoughtful contributions over the required fees.

There will be a Girls State update at Convention. **FLASH**...**FLASH**! Who will be elected Governor and Secretary of State at the 78th session? Who will be the Girls Nation Senators going to Washington D.C.? Who will receive the Samsung Scholarship? Until then...**Look to Girls State and you'll find...tomorrow's leaders of mankind**. # **BOOK OF REPORTS**

# **LEGISLATIVE 2024 – 2025**

The American Legion, through grassroots advocacy has an agenda for the 119<sup>th</sup> Congress. The most effective way to support the American Legion's Agenda is through grass roots efforts and individuals having their voice heard.

Units were encouraged to contact U.S. Senators, U.S. Representatives, State Officials, Local Officials, and the White House through the grass roots effort. This included online letters, phone calls and direct contact.

At the end of the year 2025, the Department of Arizona had 33 out of 85 reports for year-end were submitted which is an increase over last year. 8 Units actively worked on the Legislative Program. There were 25 Units that had nothing to report but submitted a report. Out of the 33 reports, five included a narrative that was eligible for a Department award. Those five were then judged by three people not affiliated with any of the participating Units. One report received after the May 1<sup>st</sup> deadline.

Information was communicated to Unit members on a regular basis by posting information on the Department website, including call to action alerts. Links to the Dispatch and various other vital information is posted there as well and members are encouraged to reach out to their Senators and Representatives. Legislative chair spoke with several District Presidents to encouraged units to vote and get their reports in. Members were also encouraged to sign up online for the Dispatch about upcoming legislation and other vital information the American Legion and the American Legion Auxiliary supports. 17 members subscribe to the Dispatch.

Information on how to find all of Arizona local Senators and Representatives was shared in a monthly bulletin posted on the Department website.

There were 912 letters sent to U.S. Senators, U.S. Representatives, State Officials, Local Officials, and the White House through the online grass roots effort. There were 624 letters mailed via US Postal Service. There were 282 other contacts with U.S. Senators, U.S. Representatives, State Officials, Local Officials, and the White House. There were 296 replies received from U.S. Senators, U. S. Representatives, State Officials, Local Officials

Members connected and met personally with State and Local officials at rallies, and other events. One Unit met with local Secretary of State officials to discuss upcoming events in the state and discuss Veterans' concerns. ALR riders and Unit members attended the annual "motorcycle day at the dome" event this year, supporting the passage of the motorcycle safety fund extension, which provides funds for motorcycle safety and training.

Ten Units promoted voting, by telling members how important voting is and to get out and vote. Several Unit members also worked at polling places and helped members that needed assistance filling out mail in ballots.

In February members from the American Legion Department of Arizona and the Auxiliary Department Legislative Chairman attended the National Conference in Washington D.C. The Arizona delegation along with other delegations from the nation, stormed Capitol Hill to urge Congress to pass legislation that the American Legion supports.

Through the grassroot efforts, the Department of Arizona has been a vital part of this year's success in Legislation that has passed and will continue to make calls and write letters as needed to advocate for veterans, active-duty military, and their family's rights.

American Legion Auxiliary Department of Arizona National Security Report Chairwomen Barbara White 2024/2025 American Legion Auxiliary members in the Department of Arizona were busy this year supporting the active military, cutting coupons, delivering supplies to active military in the California fire, attending CERT classes, hosting and attending blood drives, handing out Blue and Gold Star banners to families, supporting JROTC programs, volunteering at the USO. These a just a few of the programs that were reported.

Thomas Friendlander, National Security Chairman for the Irving B Selver Unit 107 assisted military families stationed at Naval Base Ventura County Port Hueneme. Unit 107 was mobilized to assist in family relocations and emergency response efforts. Thomas went above and beyond, personally dedicating 22 hours and driving 907 miles to help affected families evacuate and settle into temporary accommodations. His actions exemplify the Auxiliary's mission to protect and uplift those who defend our nation.

Coupons were clipped and shipped overseas for a total of \$10,190. Erenest A Love Unit 6 sent coupons four times a year with 200-300 coupons. (No dollar amount was provided.) They in turn, received a Certificate of Appreciation for their effort from Federica Lemauk, the Army Community Service Officer in Germany. They were information they supported over 55,000 families with coupons in all their commissaries overseas.

At the District 8 meetings, items were collected for active military for a total of 18 boxes. Person items, books, snacks, sewing kits, wet wipes, hats, and toiletries were collected.

They also strung the grommets on wire for the left-over fabric to be 'burned' off the grommets.

Roy Fourr Post 24, Wayne V McMartin Post 91 and Merrill-Mitchell Post 39 families had the honor of hosting the USS Arizona Legacy Foundation members.

Two units participated in Welcome Home "Parties". Forty-nine ALA members and 120 hours were donated to these events.

Only 3.2% of the Units in the Department of Arizona reported to this Chairwomen. However, of those 3.2%, the members did an outstanding job in serving the active military and their families, donating time and money, and helped where it was needed.

#### POPPY YEAR END REPORT 2024-2025

Although all units work the Poppy Program in their own way, most do not report their activity under this program. 20,300 poppies were distributed in state to the Units this year. Several Units made poppies this year and some have assistance with making and distributing poppies from Girl Scout Troops

Arizona has 86 active Units with 40 submitting reports which is an increase of seven (7) from last year and seven (7) submitting narratives for awards which is the same as last year.

The reports represent less than 50% reporting by units. Due to mailing the reports instead of email, reports were accepted until May 10<sup>th</sup> to allow for slow delivery.

Two Units sent in Posters for judging, This is an increase of one Unit from previous years. Two units who do not submit Posters have agreed to judge them.

In checking with the Junior Chair no Miss Poppy Books were submitted this year at the Junior Convention although reports reflect Units have Miss Poppy Juniors. No Miss Poppy Books were received last year at convention. Unit 115's Little Miss Poppy was featured in the May 2025 American Legion Auxiliary magazine edition. Awesome!

Units reported an estimated 3448 hours working the poppy program this year. An estimated 701 veterans or veteran families were assisted. Some of the assistance provided was in kind work or donations of goods rather than money

Unit 2 was awarded the National Unit Award last year from the Western Division. Great job! Arizona Department was awarded the National Department Award from Western Division. In consultation with a Unit 41 member, the Department Award shall be given to Unit 41 to display to honor PDP Josephine Herrera. Unit 86 had two posters that received national recognition.

This year a Poppy Power Point was created so information about Poppy and all the National and Department Awards could be reviewed from one document to save Unit members the hassle of locating the information from several computer sites.

A poppy hat contest was started last year after members asked for a contest for that purpose. Although there were not a lot of entries, Units had a chance to see what could be done and hopefully more Units will join in this year.

I thank the Units for their dedication in working this program this year.

Many stepped outside of the box this year with public relations ideas. It has been difficult getting into the main stream media for a lot of units these past years. One great thing that has helped has been social media.

Many units have created not only websites but Facebook, instagram and LinkedIn pages to help keep their members connected as well as reaching out to the community. Radio and newspapers have been improving this year on the reports as the local community newspapers seem to be opening up a bit more with available space.

Many units continued their monthly meetings with in person as well as zoom to help keep the members active and ready to help. Quite a few units even asked the Department Chairman for help in setting up the zoom meetings as well as making sure they had appropriate branding for backgrounds.

Many units reported the they were not able to locate the fall conference packets or were not given the packets although they were available on the Department website for use and download. Many reminders and walk throughs of what is available on the website have been given during conventions and conferences.

A request from units is also more training in public relations regarding social media. Be it how to set up pages, handle administrator roles and how to hand off accounts when a member leaves office or passes away. Also training for use of social media as well as tips and tricks to help keep the community and manners coming back for more. It would also be a good idea to have some training on which types of group pages are suitable and branding for all social media accounts. Thoughts for the next year's chairman for sure.

Most units used social media, newspaper, newsletters and of course websites to get out their information as well as keeping members informed. Here is a breakdown of some of the Arizona Unit activities this year.

• Robert A. Eckert Unit 81 participated in speak out radio, Murphy broadcasting, live social media broadcasting and radio central. The unit also sent in many press releases to the Riverscene on-line magazine as well as the Today's News Herald and Roddin AZ Magazine.

• Swift Murphy Unit 32 raised funds to put up an advertisement on the Chamber of Commerce billboard outside the chamber building.

• Mathew B. Juan Unit 35 continued to build upon the PR program with use of the constant contact email database where software resends to individuals that had not previously opened the first

attempted emails. The Unit worked closely to help educate both members as well at the community about veteran stand downs and how they can benefit the community.

• John Ivens Unit 42 (and family) put out press releases to the local newspaper as well as the Legiontown USA website for their annual Christmas with the children at the Grand Canyon. Many social media posts as well as flyers were sent out for the event ahead of time. The unit was joined by the District 7 President Ellen Hampton.

• Conrado Francisco Bilducia Unit 124 had a prominent event in August 2024 when they participated with the Post at the funeral of Alcario Flores. For 80 years (WWII) he was missing in France and declared dead. In April of 2024 his remains were found and identified. There were news stations everywhere and drones flying overhead. Most of the publicity of course talked about the Post, but you can see the Unit in the pictures in their matching blue shirts. There is a large posting about the event with pictures on the Guadalupe Historical Society Facebook page.

• Buckeye Unit 53 was busy as always this year with a lot of events that were posted to social media as well as the local newspaper and chamber board. The largest event was a 95th Anniversary for the charter of Post 53 where the unit reached out to the community to help gather local information and stories going back to the 1930's. The unit also coordinated with local schools to have sports teams, JROTC as well as youth leagues participate at the post home with dinners, and other social events. The unit is also creating low cost calendar events for the community to attract different interested and educate more about the foundation of the Legion family.

A total of 32 reports were turned in to the Department PR chairman out of 87 units. This has always been a struggle to get units to report at year end.

There were several Units put in for National Public Relations awards as well as Department awards. In all 2024-2025 was a great year and lots of events and promotion took place along with more use of the branding out in public to help start those elevator speeches.

An end of year is not something to be sad about. It is a great start to the next year with a great path to continue to change, evolve and follow. Blessings for the 2025-2026 year.

# DEPARTMENT VA&R YEAR-END REPORT 2024-2025

Arizona embraced the opportunity to support rehabilitation of veterans through arts, crafts and hobbies:

- 236 Veterans participated in 3 Arizona VCAF events. 11 awards were recognized at the National level with 2 First Place winners.
  - The Tucson ALA VAMC team replicated a fancy art show by serving non-alcoholic sparkling wine and charcuterie plates (photo 1). Local winners' submissions were then shown at the local Mall.
  - To engage the public, the Prescott VAMC event was held during a popular event at the County Fairgrounds.
  - With Unit donations, the Department of Arizona purchased banners and flags to promote the Phoenix event (photo 2). A dual Legion member and professional artist, assisted with setup and judging for the competition (photo 3).
- Ray Fourr Unit 24 provides supplies and volunteers with the Tucson VAMC Blind Rehab group making cards, decoupage glass jars, paracord keychains, luggage tags and more. (photo 3.5)
- 7 Units supported "HEAL HER Art", an Arizona art wellness program specifically for women veterans (photo 4). Fourteen year-old Honorary Junior President is leading an effort to engage these veterans in poppy-making by instructing and distributing poppy supplies (photo 5)!
- Multiple units support "Guitars 4 Vets"--providing guitars and lessons for veterans. The ALR at Wayne V. McMartin Post 91 initiated a ride to raise funds to establish a scholarship honoring their Post Commander's artist son who was murdered. Raising over \$9,000, the event is now an annual Legion Family event (photo 6).

Families and caregivers were not forgotten by the Arizona ALA:

- Arizona Officers attend remembrance services honoring veterans and families on Memorial Day and Pearl Harbor Day each year.
- Wreaths Across America is promoted though the Department website and social media—17 Arizona Units reported supporting the program.
  - Yuma's Sunset Vista Cemetery was featured in the WAA calendar (photo 7). Legion Family members, as local coordinators, ensure that all 724 graves are honored.
  - Oro Valley Unit 132, with fewer than 100 members, worked within their community to have 2000 wreaths sponsored through their Unit!
- Many organizations of the Yuma community, including the American Legion Family, came together to honor Gold Star Families with a By-way marker (photo 8).
- Thirty-member Conrado Francisco Bilducia Unit 124 has four dual members in the Post's Honor Guard. They brought peace to families by conducting 11 funerals/ceremonies including honoring the remains of a WWII veteran found in France (**Photo 9**).
- McCullogh-Wagner Unit 109's Memorial Blanket committee provides hand-made blankets to veterans who have passed so family members can rest assured that their loved one's last journey is made in comfort and dignity.
- Providing *Be The One* support at a local home show, Daniel Guajardo Fernandez Unit 115 and Post members provided resources to a mom whose veteran son was considering suicide (photo 10)

Arizona ALA avidly supports their 3 VAMC's (and CBOCs) and 4 State Veterans Homes.

- Four Arizona State Veterans Homes:
  - \$6050 was donated by Units; two State Homes each received Wheelchair accessible Billiard tables (photo 11).
  - Birthday, Valentine's, Holiday cards and events, by local Units, are coordinated monthly with individual State Home Chairmen.
    - HH Donkersly Unit 19 purchased neck fans for the Yuma State Home veterans and participated in a birthday party for a 102-year old WWII veteran (photo 12). They also purchased a granite bench.
    - Car Show, Art classes, Motown Live entertainment, Bingo, Carnivals are some of the activities that Units supported (photo 13).
    - Ray Fourr Unit 24 annually hand-makes 300 Christmas stockings for Tucson State Home and hospitalized veterans stuffed with goodies donated by various organizations (photo 14).
    - All veterans at two State Homes received holiday gifts from their personal wish list from William Bloys, Unit 2 and HH Donkersley Unit 19 (photos 15).
  - November 11, 2024, a Purple Heart Wall was dedicated in Yuma for 6 Purple Heart recipients (photo 16).
  - To help keep ongoing costs down, Swaskegame Unit 14 donated a \$500 engraving machine to the Flagstaff State Home.
- 3 VAMCs:
  - Nearly \$13,000 was donated by Units to support the 3 VAMC annual Gift Shops (photo 17). 510 Veterans and approximately 150 family members were served, including 50 robotic "Joy for All" pets provided to the veterans in the Phoenix memory care program (photo 18).
  - Sipe Peterson Unit 44 donated \$1,420 and 30 wigs and 210 hand knitted scarves and hats valued at \$6,500 to the Phoenix VAMC women's oncology department. (photo 19)
  - Tony F. Soza-Ray Martinez Unit 41 donated \$1,000 in daily bus passes so veterans without transportation could get to health care appointments.
  - Tucson VAMC received a new \$10,000 bingo board from the Units in Arizona! The Auxiliary also regularly supports the food pantry at the main facility and one CBOC.

The Units in Arizona reported supporting 17 Standdowns across Arizona:

- Luke Greenway Unit 1 hosted a women-veteran only standdown by providing the location, provider set-up, food and clothing distribution.
- Apache Unit 27 provided volunteers at two standdowns that served over 1000 veterans.
- Overgaard-Heber Unit 86 volunteers traveled hundreds of miles to cover 3 standdowns in northeast Arizona small towns.
- Conrado Francisco Bilducia Unit 124 members attended 6 standdowns across southern Arizona.
- A member of Sipe Peterson Unit 44 administered flu and COVID vaccines at a standdown.
- Ernest A Love Unit 6 members supported 3 standdowns across Northern Arizona.

Units supported many other like-minded organizations:

• Merrell Mitchell Unit 39 participated in an Honor Flight Homecoming

- To date, Units have donated over \$50,000 to Department President Stacey Mayberry's Special Project "Pups and Warriors Side by Side" (P.A.W.S.S.)—an Arizona organization that provides service dog training, for free, to veterans with PTSD.
- Other organizations supported included U.S. Vets, Grounded No More (an AZ organization that takes veterans for demo flights in historic aircraft), Leashes of Valor, Tunnels to Towers, Imprints of Honor (connecting students with veterans to document their story), USO, among others.

• Sipe Peterson Unit 44 held a women veteran's luncheon where they provided gifts and a flower bar (photo 20)!

Your financial contributions enable our veterans to express their creative talents. Thirteen Units donated a total of \$5,657. A member purchased 100 Diamond Art Kits which were donated to Tucson, Prescott, and Phoenix.

#### American Legion Auxiliary VA&R REPORT TUCSON VA MEDICAL CENTER 5-31-25

We are working very hard with the Recreation therapists to get our traditional events back up and running. We have wonderful volunteers for the second Saturday for Bingo at the Community Living Center but can use more help.

Ward W2 (Dementia Ward) in Building 60 is currently seeking twin size blankets for their patients (this is an ongoing need). They request that the blankets be different colors/patterns so each patient will recognize their personal blanket.

Southwestern Blind Rehabilitation Center (SWBRC) is continuing going on outings where they are invited. They would like to request support for outings which are not direct donations such as going to the movies, Pima Air & Space Museum, Botanical Garden, etc. These outings must be financed by donations of the purchase of tickets directly by the sponsor. They currently have a population of twenty.

Patriot Pantry is up and running at is currently supporting 40 to 50 Veterans with food insecurities. The current monthly cost for this program is estimated at \$1,500. VA funds can now be used to purchase the food and different donors are shopping and delivering the items to SAVAHCS. There is also a Patriot Pantry program at the Sierra Vista CBOC.

ALA is working with CLC therapists and rhe new Bingo machine has been received.

ALA sponsored refreshments for the NVCAF medal winners on April 15, 2025.

The grand total of monetary donations for the American Legion Auxiliary for May 1, 2024 to May 31, 2025 is \$5,251. Thank you Unit 131 and Unit 136 for your generous donations to support our programs.

The grand total of material and activity donations for the American Legion Auxiliary for May 1, 2024 to May 31, 2025 is \$35,848.00. Thank you Unit 24, Unit 39, Unit 66, Unit 131, Unit 132 and Unit 73 for your generous donations to support our programs.

Eight registered hospital volunteers donated time which was credited to the American Legion Auxiliary. The grand total of registered volunteer hours May 1,2024 to May 31, 2025 is 1,119.25. Twenty occasional volunteers have contributed 289.55 hours as of May 31, 2025. The Center for Development and Civic Engagement (CDCE formerly Voluntary Service) is bringing back many volunteers

This chairman has volunteered 166.25 hours and logged 1,980 miles this year in service to the Tucson VA Medical Center as of May 31, 2025. This chairman has now logged over 4,900 hours in service to SAVAHCS. This chairman was privileged to present the honorary check to the directorship of SAVAHCS in the amount of \$2,199,900 representing value of volunteer hours and donation this past fiscal year. This chairman finished a three year term on the VAVS Executive Committee. This chairman has attended every Executive Committee meeting and every VAVS meeting this year. This chairman is working with the Homeless Program to ensure that our Homeless Veterans and those in Transitional Housing have the food and beverages that they need. This chairman is actively supporting the Patriot Pantry at SAVAHCS. This chairman is working with the Recreation departments to purchase needed supplies for the National Veterans Creative Arts Program and other recreational activities. NVCA. Festival was held October 12 through October 15<sup>th</sup> with the first place winners going to Tucson Mall for display for a month. ALA purchased steel mesh screens for displaying entries. Annual Joint Review was held on November 26, 2024. VAVS Committee voted to support the Patriot Pantry, Building 95 Recreation and Fisher House with donations on July 31, 2024. VAVS voted to fund NVCA in the amount of \$3,000 which was the total requested on February 26, 2025.

In December, 7 members of Unit 62 went to the State Home and decorated for the Holidays.

Jan 31,2025 Delivered 19 sweatshirts-donated by a member of Unit 62, 25 lap blankets made by Happy Hearts of Sun City, Valentine decorations donated.

March 6,2025 St. Patty's decorations delivered.

March 21,2025 Monetary donations from Units 41, 61, and 5 in the amount of \$1600.00

March 23,2025 Delivered tie dye, and t-shirts for veterans to make on craft day.

March 29,2025

Car Show, veterans held a car show as a fund raiser for a new vehicle for the home. 12 cars attended. Veterans made tie dye t-shirts and socks, made bracelets, and painted pictures for donations. There were also blankets made by Happy Hearts given away to veterans. A food truck was there to feed veterans and guests purchased food too. Donuts and cookies were also donated by the Auxiliary. Veterans Affinity Group pinned the Viet Nam veterans and thanked them for their service. They raised \$1,060.00 in donations.

#### April 7,2025

The Auxiliary sponsored Tim Hope with TNT Entertainment to perform for the veterans singing Motown music. The veterans and staff were singing and dancing. Snacks and drinks were provided for them all. Ladies from Unit 62 were there to assist and dance with veterans and pass out snacks and drinks and to visit with them. We also celebrated one of the veteran's birthdays.

Supplies of snacks and drinks were provided to the pantry for future events and afternoon snacks. Supplies of toiletries and small gifts and games were also given for the gift shop. Also aprons and Clothing protector bibs were also made and donated. 2 \$50.00 gift cards were also presented to take some of the veterans out to lunch when they go on outings.
