

City of New Munich
City Council Minutes

September 6th, 2016

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, and Ron Doll were present, Pat Nathe and Dan Krueger were absent.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the minutes from August 1st, 2016 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of one Rescue call last month. They are granted \$3,400 for training for their fiscal year which starts July 2016. They are done with the maintenance on the fire hydrants. They found a few that did not drain all the way; they are going to work on them. The hydrant at the intersection of Liberty Street and 5th Ave E needs to be replaced. Allen has a list of a few which should be put on the list for replacement next year. Allen submitted a few bills that need to be paid, Freeport Screen Print \$1433.10, Motorola \$4801.96 and Central McGowan \$18.32.

On a motion by Ron Doll, seconded by Shawn Duevel carried and approved, The Fire Department will apply for the Minnesota Fire Department Turnout Gear Washer/Extractor Award program for 2017. (State Fire Marshal)

Waste/Water Operator, Tom Valerius was present to inform the Council that on the Waste/water end, the system is running fine. On the water end the high level alarm on the North lift station went off. Preferred Control came out to show Tom how to re-set the system alarms and Tom will be testing the alarms monthly. The fluoride levels are a little low and Tom is working with the State of Minnesota to get the level up.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the following building permit was approved, Worms Lumber & Ready Mix.

On a motion by Shawn Duevel, seconded by Ron Doll carried and approved, Shady's will use their catering license for an outdoor event (Bar Olympics) on Saturday, October 1st from 2pm-8pm.

Dan Martin was present to complement the Fire Department on a good job when flushing hydrants. He also asked about the City website. We informed him that Shawn Duevel is working on the new website and some of the information is not on it yet. We also informed him that the new website address is www.cityofnewmunich.org. This was also in the newsletter that was sent out this summer.

On a motion by Shawn Duevel, seconded by Ron Doll and carried Resolution 9-16-A was approved.

Lyle Klaseen was present to inform the Council that they would like to install a fence between the east side of the ball fence and the cemetery wall. They would leave room on both sides so a car can fit through. He asked if the lease and sublease could be amended. The Jaycees will pay for the attorney fees to amend the lease and sublease agreement. Then it has to be approved by the Church, St Cloud Diocese, and the Bishop and back to the City.
