SUMMIT LAKE PAIUTE TRIBE**

RESOLUTION NO.: SL - 63 - 2024

TITLE: APPROVAL OF PARTICIPATION AND TRIBAL REPRESENTATIVES FOR THE NRCS NV TRIBAL CONSERVATION ADVISORY COUNCIL

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe (SLPT) membership; and

WHEREAS, the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife native to the Summit Lake basin and aboriginal area of the SLPT; and

WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, plants, and infrastructure within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the SLPT; and

WHEREAS, the Natural Resources Conservation Service (NRCS) in Nevada has offered participation to SLPT in the newly formed Nevada Tribal Conservation Advisory Council (NVTAC); and

WHEREAS, to participate in the NVTAC, the Council must designate a representative via resolution; and

WHEREAS, the Council designates the NRD Director, James Simmons, as the primary representative, and a NRD Fish/Wildlife Biologist (that Mr. Simmons assigns) as an alternate representative when he cannot attend meetings; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to participating in the NRCS NV Tribal Conservation Advisory Council and assigning the above stated representatives; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
