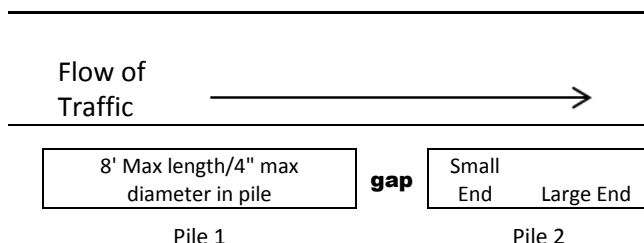
### Brush Pick-up

Brush pick-up is scheduled for the following weeks:

April 8      June 10      Aug. 19      Oct. 7

- Pile brush at the curb pointing the cut/heavy end with the flow of traffic.
- Brush piles must run parallel with the road
- Small brush must be in an open container or CLEAR bag.
- Trim limbs per the Village Ordinance. Limbs larger than 4" in diameter or 8' in length **will not be picked up**.
- Brush must be set out at the curb by Monday at 7 a.m. of the scheduled pick-up week.
- Do not set out brush more than 5 days before the scheduled Monday.
- Brush generated by tree removal contractors will not be picked up.
- Please call with questions; brush not properly stacked will be red tagged and your responsibility to dispose of.

### Blowing/mowing grass into the street

Per ordinance 9-3-2 (c) no person shall deposit any refuse, leaves or grass clippings in any gutter along any public street, road, alley or highway. Please protect our storm sewers and sweep up if you must blow into the street.

### Village Board

Village Board meetings are held the 3<sup>rd</sup> Tuesday of the month at 7 p.m. Feel free to attend and find out the happenings in the Village.

### Open Burning – Village Ord. 3-2-11

Burning trash/garbage is prohibited. Burning barrels are no longer allowed within the Village of Pardeeville. Spring burning of dry leaves and other non-offensive dry yard debris is only allowed from April 1<sup>st</sup> through May 31<sup>st</sup>. Burning of damp yard waste and unattended burning is also prohibited and is subject to a citation/forfeiture for violations. Outdoor cooking and campfires are allowed per Village Ordinance. See the Village Code of Ordinances or call the Village Hall if you have any questions.

### Private Wells

All private wells and sand points must comply with D.N.R. codes and Village ordinances and are required to have a valid permit, but all wells in basements are illegal and must be properly abandoned and inspected by the Village. Failure to comply will result in a citation. Call the Village Hall to renew your Private Well Operation Permit or to get information on a free permit to abandon your illegal basement well.

### Regulation of Length of Lawn and Grasses Village Ord. 6-1-8

Lawns, grasses and noxious weeds on lots or parcels of land which exceed eight (8) inches in length adversely affects the public health and safety of the public in that they tend to emit pollen, and constitute a fire hazard and a safety hazard in that debris can be hidden in the grass. For that reason, any lawn, grass or weed on a parcel of land which exceeds eight (8) inches in length is hereby declared to be a public nuisance. **\*\*In any case where the owner or occupant fails to cut the lawn, grass or weeds, the Village may elect to cut the lawn, grass or weeds and shall charge the expense of doing so to the property owner.**

### **Hydrant Flushing**

The Pardeeville Water Dept. will be flushing water mains during the weeks of May 20<sup>th</sup> – 24<sup>th</sup> and from October 7<sup>th</sup> – 11<sup>th</sup>. This flushing will be done during the day from 8:00 AM to 4:00 PM in order to maximize the results of our flushing program. Some discoloration of the water might be noticed. The Utility recommends that residents run water from the cold water tap and flush toilets until the discoloration disappears.

### **License Your Pet(s)**

April 1<sup>st</sup> is the deadline to license your dogs and cats. After April 1<sup>st</sup> there will be a late fee of \$5.00 per animal. Please remember to bring in proof of rabies vaccination from your veterinarian's office.

Fine for an unlicensed pet is \$218.50

Please Remember...

- ❖ Dogs/Cats must be leashed and not allowed to run free.
- ❖ Please clean up after your pet if you let them do their duty in someone's yard or public way

### **Permits, Ordinances, Setbacks**

There have been numerous violations concerning the following Village Ordinances:

- Not parking on hard surface
- Blowing grass into streets
- Allowing dogs/cats to run freely (not leashed or fenced)
- Barking dogs
- Fences

The Village Ordinance Book is posted on our website. When in doubt, call the Village office.

Residents are reminded that ***permits must be obtained for most property improvements.***

When planning your construction project, please allow a two-week time frame for appropriate permits, estimates, locates, etc.

Payment Arrangements need to be made prior to disconnection day, require ½ down and need to be signed. Please call the office at 608-429-3054 if you need to make arrangements.

Utility bills are mailed on the last working day of the month and due the 20<sup>th</sup> (or next business day if it falls on a weekend). If you do not receive your bill, please call the office and we can reprint for you. Failure to pay by the due date will result in a penalty and past due notice being generated.
