CSNC Spay & Neuter Release Form

Cabarrus Spay & Neuter Clinic (CSNC) uses qualified staffing and approved materials for all procedures performed. It is important for you to understand that the risk of injury or death, although extremely low, is always present just as it is for humans who undergo surgery. Carefully read and understand the following before signing your name.

I, acting as owner or agent of the pet named above, hereby request and authorize CSNC, through whomever veterinarians they may designate, to perform an operation for sexual sterilization of the animal named on the above portion of this form.

I understand that the operation presents minor hazards and that injury to or death of such an animal may conceivably result, for there is some risk in the procedure and the use of anesthetics and drugs in providing this service. I understand the inherent risks of failing to maintain current vaccinations and waive all claims arising out of or connected with the performance of the operation due to such failure. I certify that my animal is in good health and has had no food since 12:00 midnight the evening prior to surgery. I understand that CSNC has the right to refuse service to any animal to whom surgery is deemed a health risk.

I understand that CSNC may not perform a complete physical examination before surgery is performed. I also understand that my animal will not receive pre-operative bloodwork; I waive my right to have this service performed prior to surgery at a full-service veterinarian. I understand that some factors significantly increase surgical risk, including but not limited to, pregnancy, estrus, & diseases such as Feline Immunodeficiency Virus, Feline Leukemia & heartworms.

I understand that if my animal is pregnant, the pregnancy will be terminated at surgery and there will be an additional charge of \$15 for cats and \$25 for dogs. I understand that there may be additional fees for any unforeseen circumstances regarding animal tissue abnormalities discovered during surgery. In accordance with High Volume Spay Neuter Standards, a small green tattoo will be applied to my pet to indicate spay/neuter status.

I hereby release the CSNC, all veterinarians, assistants, volunteers, directors and employees from any and all claims arising out of or connected with the performance of this surgical procedure or any adverse reactions from vaccinations. I agree that I have not and will not claim any right of compensation from them, or any of them, or file action by reason of such sterilization or attempted sterilizations of such animal or any consequences related thereto. Owner/agent agrees to indemnify and hold CSNC harmless for any damages caused during the transportation of the animal, or for any damages caused by any unforeseeable events like fire, vandalism, burglary, extreme weather, disasters or acts of God.

1. CSNC is not responsible for any personal items brought in with pet at the time of surgery. Pick-up time is 2pm and we close our building promptly at 3pm. Any animal that has not been picked up at closing, will be subject to overnight stay and an overnight fee of \$50. Please be aware that no member of the staff is on the premises overnight, and owner assumes all risk for their unattended pet.

2. If your pet has a flea infestation, it will be treated temporarily with Capstar prior to surgery at a cost of \$5 to help prevent surgical complications. We would be happy to discuss monthly flea preventative options with you.
