

**RED RIVER GROUNDWATER CONSERVATION DISTRICT**  
**NOTICE OF PERMIT HEARING**

Notice is hereby given in accordance with Section 36.404(c) of the Texas Water Code that the Board of Directors of the Red River Groundwater Conservation District ("District") will conduct a permit hearing on a Production Permit Application as set forth in detail below at 10:00 a.m. on Thursday, June 19, 2025, at the District office located at 5100 Airport Dr., Denison, Texas 75020.

A hearing will be conducted on the following Production Permit Application:

**New Production Permit**

- a. **Applicant:** White Shed Water Supply Corporation; 5167 FM 273, Ivanhoe, TX 75447  
**Location of Well:** 1276 E. FM 1396, Ravenna, TX 75476; Latitude: 33.694417°N Longitude: 96.165394°W; about 5,200 feet west of FM 273 and about 535 feet south of FM 1396, in Fannin County.  
**Purpose of Use:** Municipal/Public Water System  
**Requested Amount of Use:** 55,000,000 gallons per year  
**Production Capacity of Well:** 400 gallons per minute  
**Aquifer:** Woodbine

The Production Permit Application, if granted, would authorize the Applicant to drill and operate a water well within the District according to the terms and conditions set forth in the permit. Persons desiring to protest or provide comments on this application must comply with District Rules 5.4 and 5.8. In order to officially protest the application, a person must submit a written contested case hearing request to the District not later than three (3) calendar days before the scheduled hearing date, or no later than Monday, June 16, 2025.
