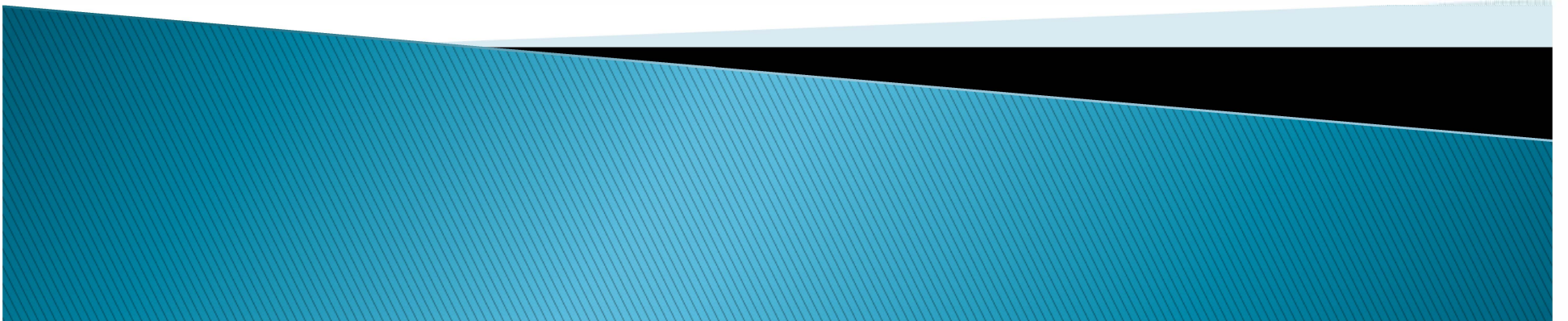


FDOT BID MATCHING



How does bid matching work?

- ▶ As soon as a project is let the proposal is broken down line item by line item.
- ▶ Each DBE that has joined the program will receive an email with work opportunities that match its NAICS codes. This means you will receive a pdf with the specific work that you are listed with the FDOT as performing.
- ▶ From the pdf, you will be able to access both the proposal and a list of primes that have requested a copy of the proposal



- ▶ You will receive separate emails for each work type that you do.
- ▶ On each email there will be a link to a web page that will show you all the past and present lettings for that specific type of work.
- ▶ The next group of slides will show an example of the reports you will receive via email and demonstrate how to use those reports.

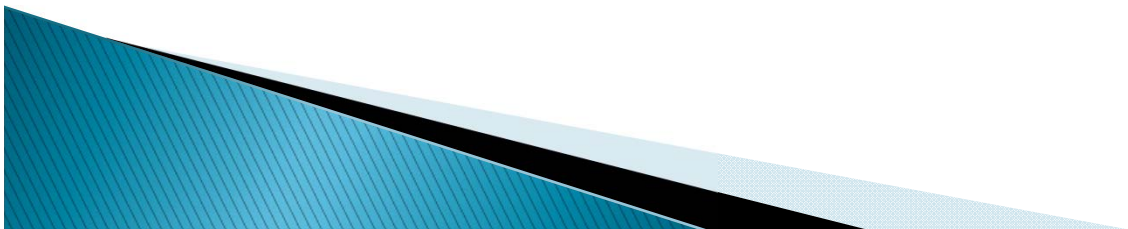
