AN ORDINANCE OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AUTHORIZING THE SALE OF INTOXILYZER S-D3 PORTABLE BREATH TESTER OWNED BY THE VILLAGE OF CHAPIN, ILLINOIS

WHEREAS, the Corporate Authorities find that it is no longer necessary or useful to or for the best interests of the Village of Chapin, Illinois, to retain ownership of the Village of Chapin Police Department's Intoxilyzer S-D3 Portable Breath Tester; and

WHEREAS, the Corporate Authorities determine that it was in the best interests of the Village of Chapin to sell old and outdated Portable Breath Tester at the price of \$100.00.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find that the old and outdated Intoxilyzer S-D3 Portable Breath Tester, is no longer necessary or useful to the Village and the best interests of the Village will be served by its sale.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President is hereby directed to take all necessary action to sell the PBT for \$100.00.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
