Ed - Updates from President

- CR1 Electrical Work for the Signs
 - All electrical work completed.
 - Received invoice from Brock Electric and forwarded to Duke Energy for reimbursement (\$3,698). Reimbursement still pending.
- Daventry Follow-Up
 - Water irrigation isn't working at Alt 19 median; working to resolve within 30 days with a battery operated control. We could consider soaker hose but unsure if enough water will come out.
 - Picnic table revisit options and purchase within 30 days.
- Pond Tree Concerns
 - Met with pastor from church. Church installed fence. Pastor had some trees taken down in the past that were hanging over fence and low lying.
 - Need to communicate to community that removal of trees or plants in our common areas is not permitted. Concerns should be escalated to HOA Board.
- Irrigation
 - o Contract with Westcoast/Sunrise expiring on May 31st, 2025
 - Bidding out to additional vendors
 - o Pond PVC pipe broken and fixed by Ed and Dave
- Discussed Resident Concerns
 - Electric scooters Community have expressed concerns that children are not stopping at signs and requested we notify the community to remind children to be careful when riding on scooters. Recommend we include in newsletter.
- Board admin session
 - o Working meeting to review roles and responsibilities. Review and access google drive.
 - o Tentative date of April 15th
