WELCOME BY MAYOR

At 5:00 P.M., Mayor Taylor led the gathering in the Pledge of Allegiance to open the meeting.

CONSENT AGENDA

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to approve the October vouchers and invoices Trustee Schober reviewed for reasonableness and which were submitted for payment approval. Payments totaling \$1,335,952.91 were authorized for all funds.

The Board thanked the department heads for their monthly reports.

MAYOR

Mayor Taylor introduced Randy Shepard, the partner from Bonadio & Co. who oversaw the audit engagement of the Village of Newark. He reviewed the audit report and shared some highlights with the Board, noting that there were no material issues. Mr. Shepard also stated that the audit report opinion would be unmodified, which is the highest level of assurance that can be issued on the audit report.

FIRE CHIEF RUSTY HAVERT

Chief Havert noted the following:

- 454 calls for service YTD.
- Thanked the Board members for attending the dedication of the new Rescue 7 Truck.
- Stated that the old Rescue 7 Truck has not sold yet, and only minimal interest has been shown in the vehicle so far. Board consensus was to use whatever advertising tool necessary to obtain the highest possible price for the sale.

AECC DIRECTOR MIKE MUSCOLINO

Mr. Muscolino spoke on the following:
