


- B. Snowplowing Rates.** Motion by Feldpausch, second by Tonkin to approve a snowplowing bid from Steve Case for the 2020-2021 season: \$100 per time for Township Hall up to 3", \$50 per time for Cloverdale Park up to 3", \$90 per hour for Brush Ridge Cemetery, salt & shovel the hall \$40 per time, snowfall amounts over 3 inches = \$90 per hour (prorated) . Roll call vote. All in favor. Motion passed unanimously.
- C. Trustee Messelink Resignation Letter.** Motion to accept the resignation letter by Jackson, second by Peake. Roll call vote. Motion carried unanimously.
- D. SWBCSA Board Representative.** Motion to appoint Matt Peake as the SWBCSA board representative term ending 3/31/2022 by Tonkin, second by Jackson. Roll call vote. All in favor. Motion carried unanimously.
