The Governing Body of the City of Garnett met in regular session on September 24, 2019 at 6:00 p.m. at City Hall with the following individuals present Greg A. Gwin, Mayor; and Brigitte Brecheisen-Huss, City Commissioner; Chris Weiner, City Manager; and Travis Wilson, City Clerk. Jody Cole, City Commissioner and Terry J. Solander, City Attorney were absent.

CALL TO ORDER

Mayor Gwin called the meeting to order at 6:00 p.m.

The Pledge of Allegiance was recited, followed by Reverend Doug Meyer giving the invocation.

APPROVAL OF MINUTES

The Governing Body reviewed the September 4, 2019 Special City Commission Meeting minutes. A motion was made by Mayor Gwin to approve the September 4, 2019 Budget Workshop Meeting minutes. Commissioner Brecheisen-Huss seconded the motion. Motion passed 2-0.

The Governing Body reviewed the September 10, 2019 City Commission Meeting minutes. A motion was made by Mayor Gwin to approve the September 10, 2019 City Commission Meeting minutes per discussion. Commissioner Brecheisen-Huss seconded the motion. Motion passed 2-0.

CITIZENS TO BE HEARD

Carl Rockers asked what kind of progress has been made on the corner of First Avenue and Elm Street. City Manager Weiner commented Bettis Asphalt plans to be here in the middle of October to complete our planned street work this year as well as to look at a couple of problem areas which include Elm street. He also mentioned the alley behind Mr. Rockers property will be widened out as well to correct the issue with it.

- Consideration of Semi-Monthly Bills in the amount of \$153,628.79. After discussion, Commissioner Brecheisen-Huss made a motion to approve the semi-monthly bills in the amount of \$153,628.79. Mayor Gwin seconded the motion. Motion passed 2-0.

Mayor Gwin commented he would be willing to participate in a City Commission Candidate Forum.

The KDOT Visioning Summary was discussed.

The City Manager’s report was received and discussed.

Mayor Gwin mentioned the 2020 Public Budget Hearing will be held on October 1st at 6:00 p.m.


Mayor Gwin mentioned the Joint City/County Commission Meeting will be held on October 7th at 6:30 p.m. in the County Annex.

There were no citizens to be heard.


ADJOURNMENT
