- <u>Fire Account Firefighter Training</u> \$19,000.00 was spent on firefighter labor and training. There is money available in the station budgets. Need to discuss further with Jason Brown Fire Chief.
- <u>Chris Boucher Efficiency Maine/ Nature Conservancy Grant:</u> The Town of Baldwin was awarded the Nature Conservancy grant and is eligible for the efficiency maine rebate. There is a meeting Thursday at 8AM to discuss figures with Chris and get a firm price.
