# **COMMUNITY SUPERVISOR'S REPORT**

All facilities that get winterized will be November 12 (turning off water, drain and clear)

Budget was cut \$34000. (Went from \$120,000 to spend in a year to under about \$86,000.) Countywide is over \$500,000. Looking to trim up budget. Asking for programs to line own fields if possible to save staffing money. Open/Drop in gym times were eliminated to save \$6,000. Programs may need to streamline facility use. Instead of using 5 facilities at once, possibly using 3 facilities for longer in a day. The most need thing is accurate scheduling so staffing can be scheduled. Both practice and game schedules – who is at what facility and when.

Background check process – all volunteers must have a background check. Coming in the future, all volunteers will need to be fingerprinted. The county incurs the cost every year in the current process. Over the course of time the new process and requirements should save money. You will still need to register as a volunteer each season, but you will need to get fingerprinted only once. Every one who volunteers – coaches, board member, team parent, goalie coaches, etc – will need to be fingerprinted. Volunteers will not need to pay for fingerprinting, the county will cover the cost. The county will be notified from the police if a violation occurs and remove the person from the role in your program. Stations will be set up around the county and you will sign up and attend one of those sessions. More information will be shared as it becomes available.

Programs may want to have a volunteer coordinator to make sure your program is compliant.

Q: If you have been fingerprinted elsewhere/through the county, will those systems be shared to save money?

A: It is a different system.

Q: Will there be a grace period?

A: They will set up times. Looks like fall and winter programs in July, spring and summer programs in January.

Q: Will adult program volunteers need to be fingerprinted?

A: Yes, adult programs need to do as well.

Q: When will this start?

A: Mid to late October was the date given, but no further information.
